ORDER FOR PAYMENT OF GAL FEES

This cause came before the court on the Guardian Ad Litem's Motion for Interim payment of fees. Said Motion is hereby granted. The clerk of court is holding the sum of \$500.00 as payment of initial GAL fee by the Plaintiff. The clerk of court is ordered to immediately disburse said sum to Nicole Saia, GAL.

The balance due to the Guardian Ad Litem per her invoice submitted is: \$10,225.00, less credit to each party of \$500.00, leaving the balance due in the amount of \$9,225.00. The Court approves this fee. Each party shall pay one-half of the fee by making payments in the amount of \$1,200.00 per month, due and payable on the 17th day of each month, until paid in full. Both parties shall send payments directly to the Guardian Ad Litem, Nicole Saia at 270 Doug Baker Blvd., Suite 700-322, Birmingham, AL 35242. The payment schedule is set so as to have the balance paid prior to the trial date.

A judgment is entered against the Plaintiff and Defendant for the GAL fee for which execution may lie. The Guardian ad Litem shall not seek execution so long as the parties comply with the payments as set forth herein.
