

ARTICLES OF ORGANIZATION

OF

The undersigned, in order to form a limited liability company under and pursuant to the laws of the State of Alabama, hereby adopt the following Articles of Organization:


1. NAME: Unique Jewels & Gems LLC

- 2. **PERIOD OF DURATION**: The period for the duration of the company shall be perpetual, unless otherwise dissolved pursuant to its Operating Agreement, which shall be maintained in the company's registered office.
- 3. **PURPOSE**: The purpose for which this company is organized to be a limited liability company under the Alabama Limited Liability Company Act including, but not limited to:

- To participate with any person, partnership, trust, estate, firm, association, corporation or limited liability company in any general partnership, limited partnership (whether as general partner or as limited partner, or both), joint venture, syndicate, pool or other association of any kind and to enter into any lawful arrangements for sharing of profits, union of interest, syndication, pooling of interest, reciprocal concession, joint ownership, or cooperation, as partner (general or limited), joint venturer, or otherwise, with any person, partnership, trust, estate, firm, association, corporation or limited liability company, for the purpose of any transaction, undertaking, or arrangement, or the carrying on of any business within the power of a limited liability company organized under the laws of Alabama, whether or not such participation or arrangements involve sharing or delegation of control over the business or properties of this company with or to persons other than this company's members and whether or not such participation or arrangements involves the conduct, management, participation or ownership of any Jewelry related business.
