Commence at the Northwest Corner of the Southwest 1/4 of the Northeast 1/4 of Section 23, Township 20 South, Range 3 West; thence run in an Easterly direction along the North line of said 1/4-1/4 Section for a distance of 74.70 feet; thence turn an angle to the right of 88 degrees 40 minutes and in a Southerly direction for a distance of 750.67 feet; thence turn an angle to the left of 103 degrees 26 minutes 45 seconds and in a Northeasterly direction for a distance of 402.84 feet; thence turn an angle to the left of 76 degrees 31 minutes 45 seconds and in a Northerly direction for a distance of 60 feet; thence turn an angle to the left of 90 degrees and in a Westerly direction for a distance of 20 feet to the point of beginning; from the point of beginning thus obtained, thence turn an angle to the right of 90 degrees and in a Northerly direction for a distance of 40.01 feet; thence turn an angle to the left of 90 degrees 01 minutes 30 seconds and in a Westerly direction for a distance of 176.86 feet; thence turn an angle to the left of 90 degrees and in a Southerly direction for a distance of 126.49 feet; thence turn an angle to the left of 103 degrees 26 minutes 45 seconds and in a Northeasterly direction for a distance of 137.57 feet to the point of beginning of a curve to the left, said curve having a central angle of 76 degrees 31 minutes 45 seconds and a radius of 56.07 feet; thence along the arc of said curve to the left for a distance of 74.89 feet to the point of beginning; being situated in Shelby County, Alabama.

ALSO, commence at the Northwest corner of the Southwest 1/4 of the Northeast 1/4 of Section 23, Township 20 South, Range 3 West; run thence in an Easterly direction along the North line of said 1/4 1/4 Section for a distance of 74.70 feet; thence turn an angle to the right of 88 degrees 40 minutes and run in a Southerly direction for a distance of 556.99 feet; thence turn an angle to the left of 90 degrees and in an Easterly direction for a distance of 194 feet to the point of beginning; from the point of beginning thus obtained, thence continue along last described course for a distance of 176.86 feet; thence turn an angle to the left of 89 degrees 58 minutes 30 seconds and in a Northerly direction for a distance of 125 feet; thence turn an angle to the left of 90 degrees 01 minutes 30 seconds and in a Westerly direction for a distance of 176.91 feet; thence turn an angle to the left of 90 degrees and in a Southerly direction for a distance of 125 feet to the point of beginning; being situated in Shelby County, Alabama.
