That for and in consideration of **TWO HUNDRED FORTY THOUSAND AND NO/100 (\$240,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **NED R. BATCHELOR and LISA SATTERFIELD BATCHELOR (WHO IS ONE AND THE SAME PERSON FORMERLY KNOWN AS LISA SATTERFIELD)**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **MATTHEW C. HUTTO and DARLENE P. HUTTO and JENNY R. HUTTO**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

**Subject to:**


1. General and special taxes or assessments for the year 2019 and subsequent years not yet due and payable.



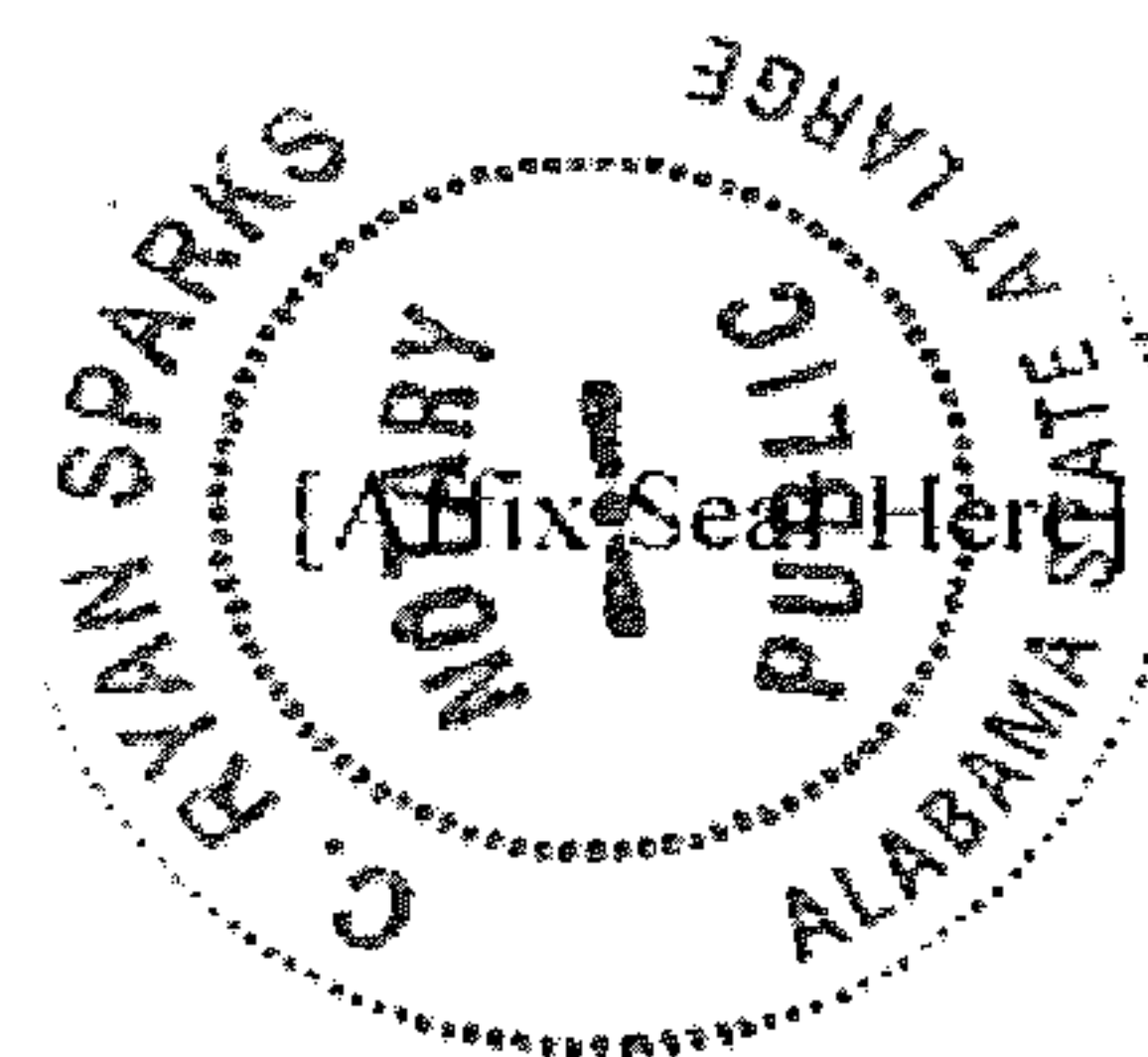
