
1. Ad valorem taxes for the current tax year.

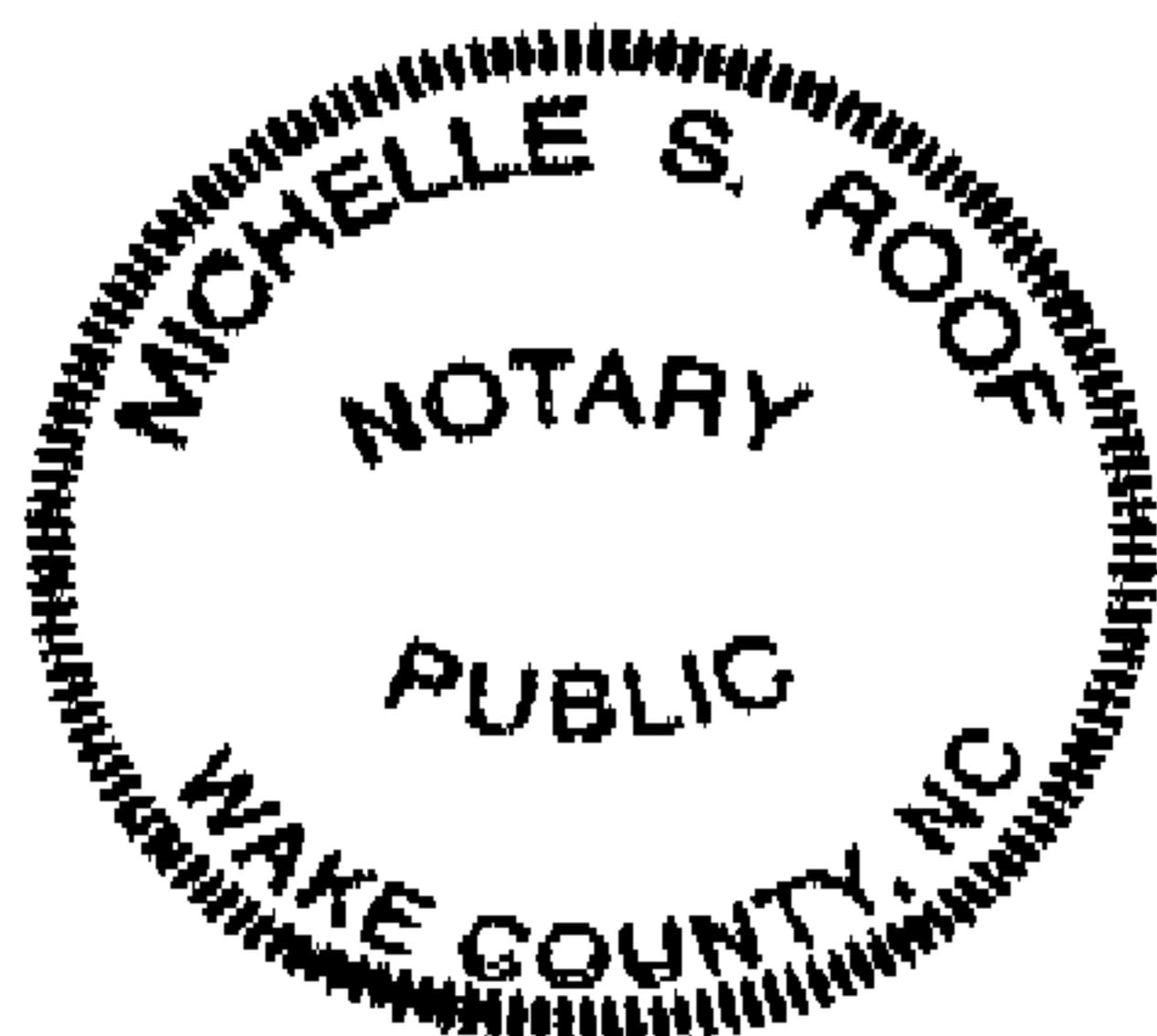




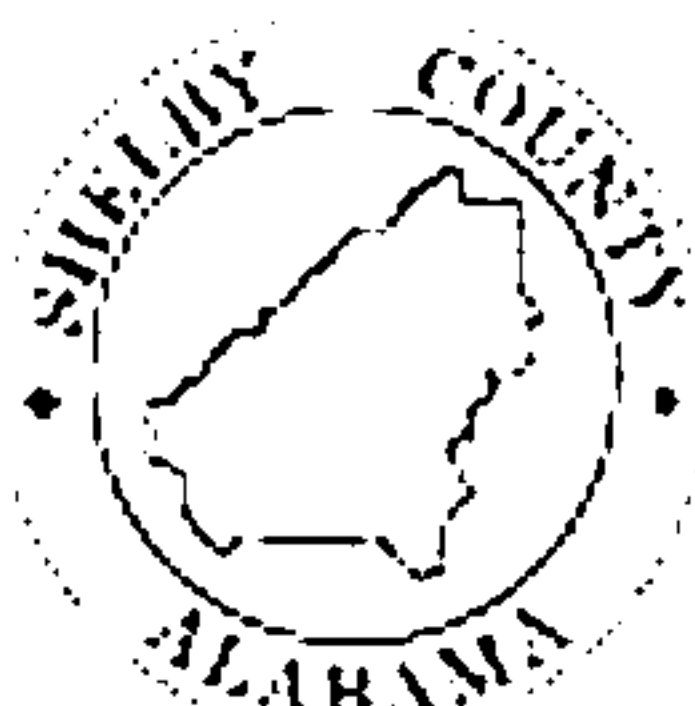
