WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Eight Hundred Seventy Thousand and 00/100 Dollars (\$870,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

Kristen R. Merriam, a married woman

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Thomas A. Luttrell and Mary M. Luttrell

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 10, according to the Final Plat of the Residential - Private Subdivision Stonegate Realty Phase One, as recorded in Map Book 29, Pages 4 A & B, in the Probate Office of Shelby County, Alabama

\$782,130.00 of the proceeds come from a mortgage recorded simultaneously herewith.

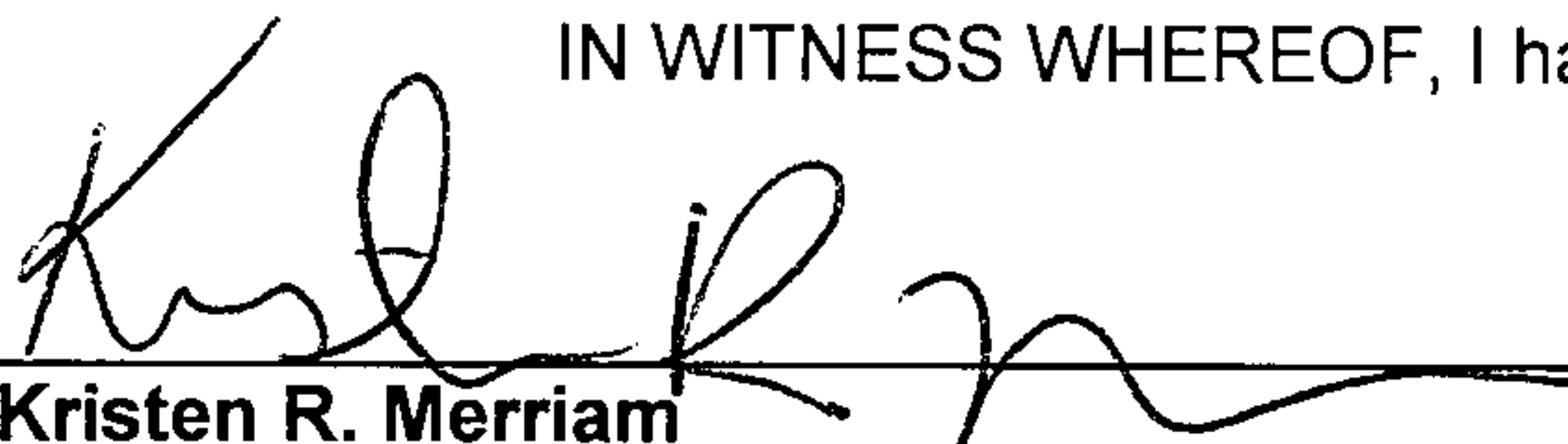

And I do for myself and for my heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

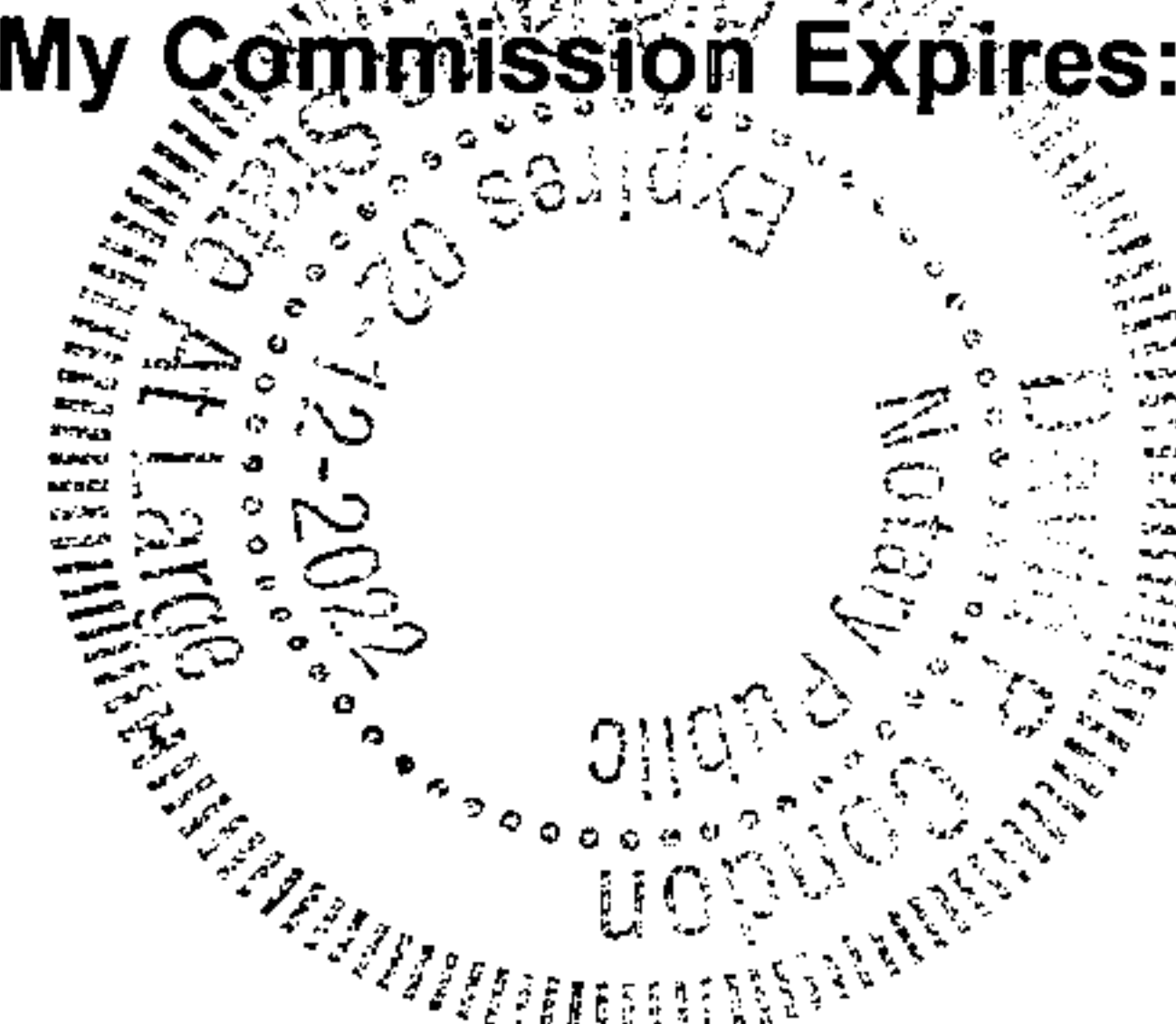

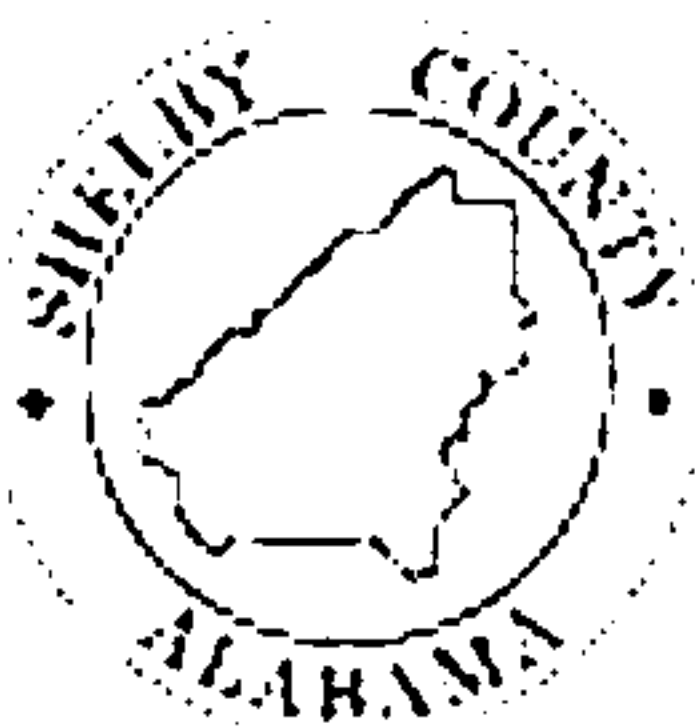
