This Property does not constitute the Honestead of the Granter nor his spouse.

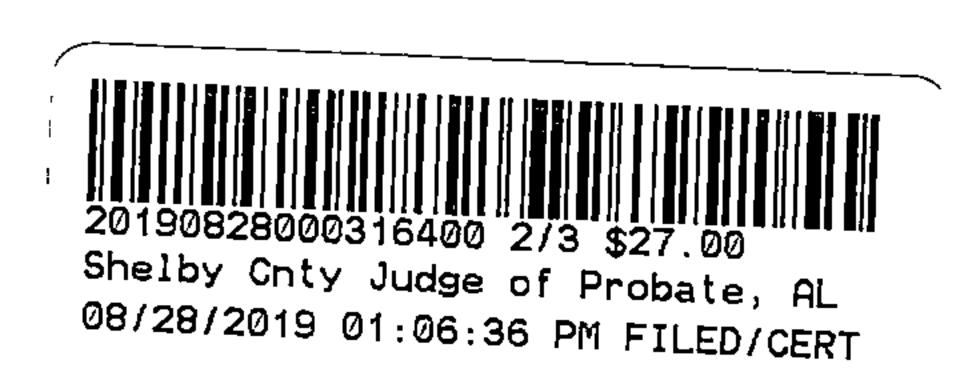

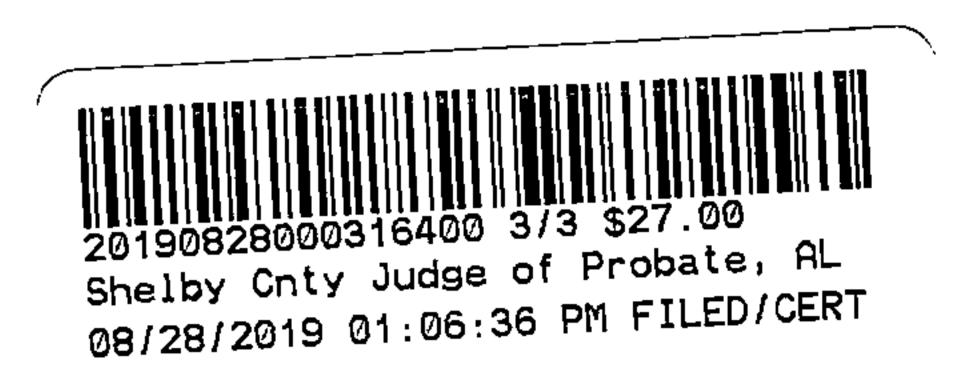
