Know All Men by These Presents: That in consideration of **Two Hundred Sixty-Five Thousand and 00/100 Dollars (\$265,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, I, **I. RIPON BRITTON, JR. Esq. as Conservator of the Estate of Hobson Dyar Burttram, Jr., an incapacitated person needing protection, under Shelby County Probate Case No. PR-2018-000299**, an unmarried man (herein referred to as Grantor), grant, bargain, sell and convey unto **RONALD C. HARRISON, MARCIA L. HARRISON and AMY R. HARRISON** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 17, Block 4, according to the Survey of Norwick Forest Second Sector, as recorded in Map Book 13, Page 23 A & B, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

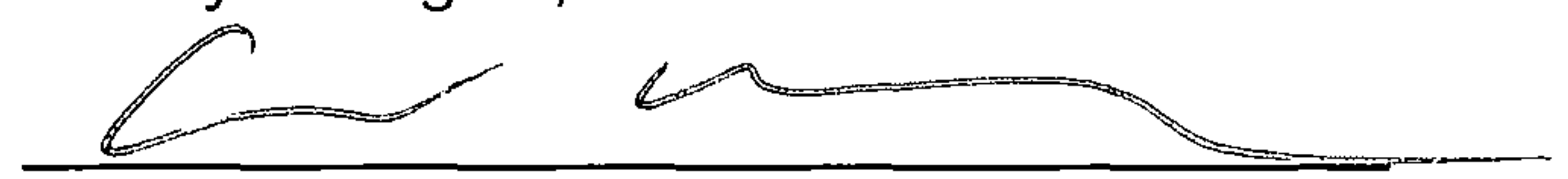
