Know All Men by These Presents: That in consideration of **Four Hundred Forty-Eight Thousand and no/100 Dollars (\$448,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **JEFFREY S. JILES and CHRISTI M. JILES** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 410, according to the Survey of Amended Plat of Grey Oaks Sector 4, as recorded in Map Book 50, Page 23, in the Probate Office of Shelby County, Alabama.

Subject to mineral and mining rights if not owned by Grantor. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

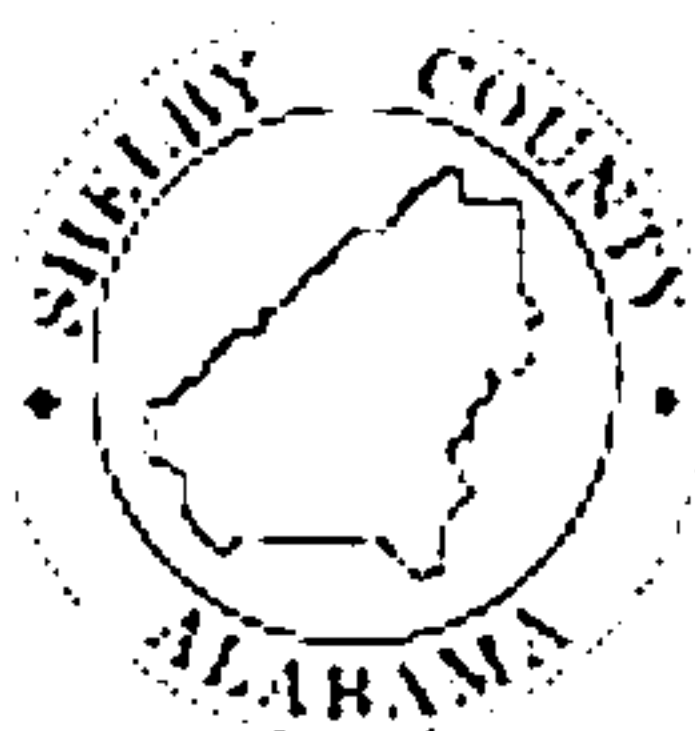
