KNOW ALL MEN BY THESE PRESENTS: That in consideration of TWO HUNDRED NINETY NINE THOUSAND DOLLARS AND NO/100 (\$299,000.00), good and valuable consideration, in hand paid by the GRANTEE/S herein, the receipt whereof is acknowledged, we, **MICHAEL S. WILSON and LATOYA JACKSON WILSON, f/k/a LATOYA E. JACKSON husband and wife**, (hereinafter referred to as **GRANTORS**), do hereby, subject to the matters, limitations, and exceptions hereinafter described, GRANT, BARGAIN, SELL, AND CONVEY unto JOSEPH WILLIAM CHANCE AND EARL KENT SEAMAN, II, FOR AND DURING THEIR JOINT LIVES AS JOINT TENANTS AND UPON THE DEATH OF EITHER, THEN TO THE SURVIVOR IN FEE SIMPLE, (hereinafter referred to as **GRANTEE/S**), the following real property located in Shelby County, Alabama:

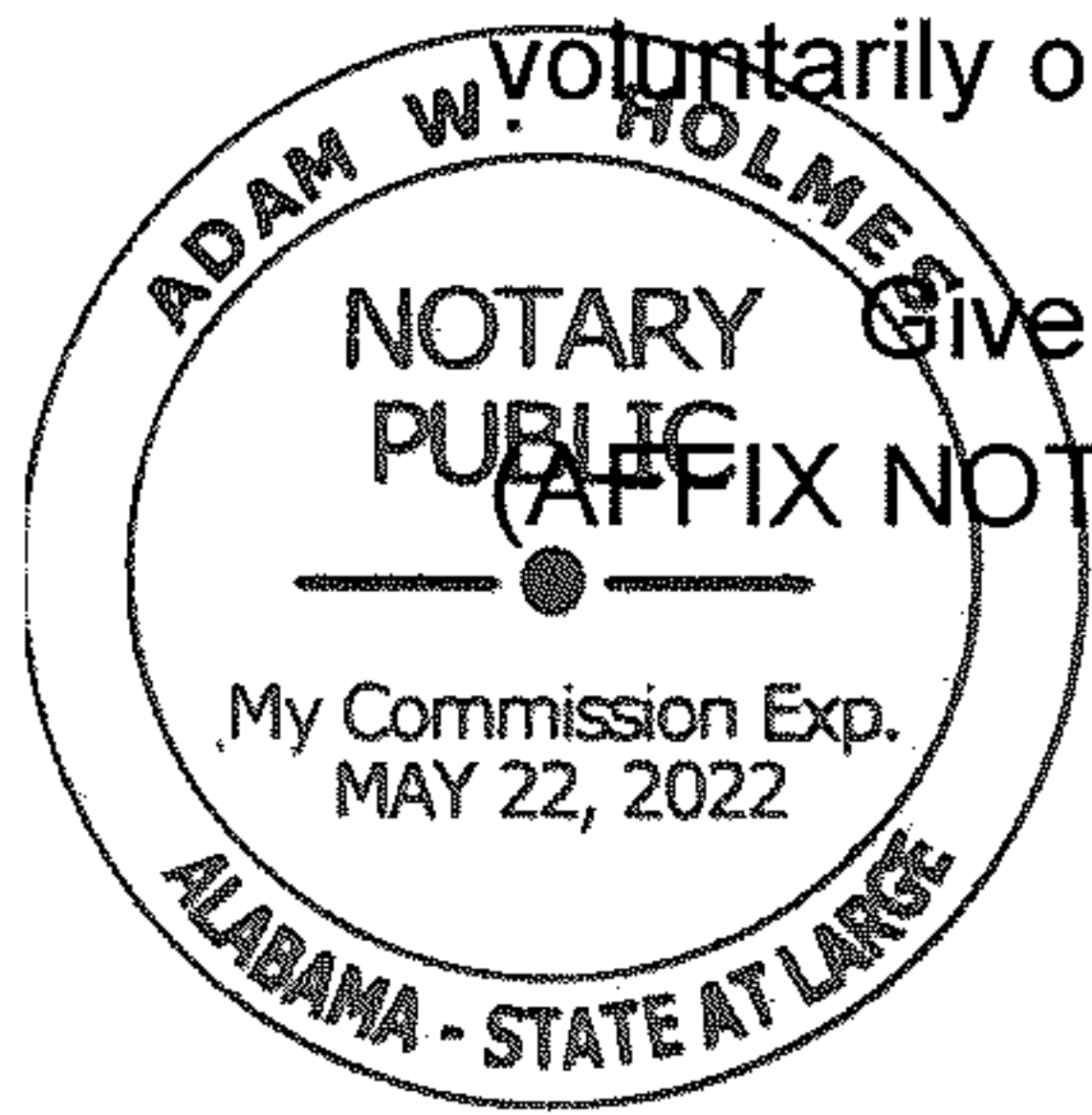



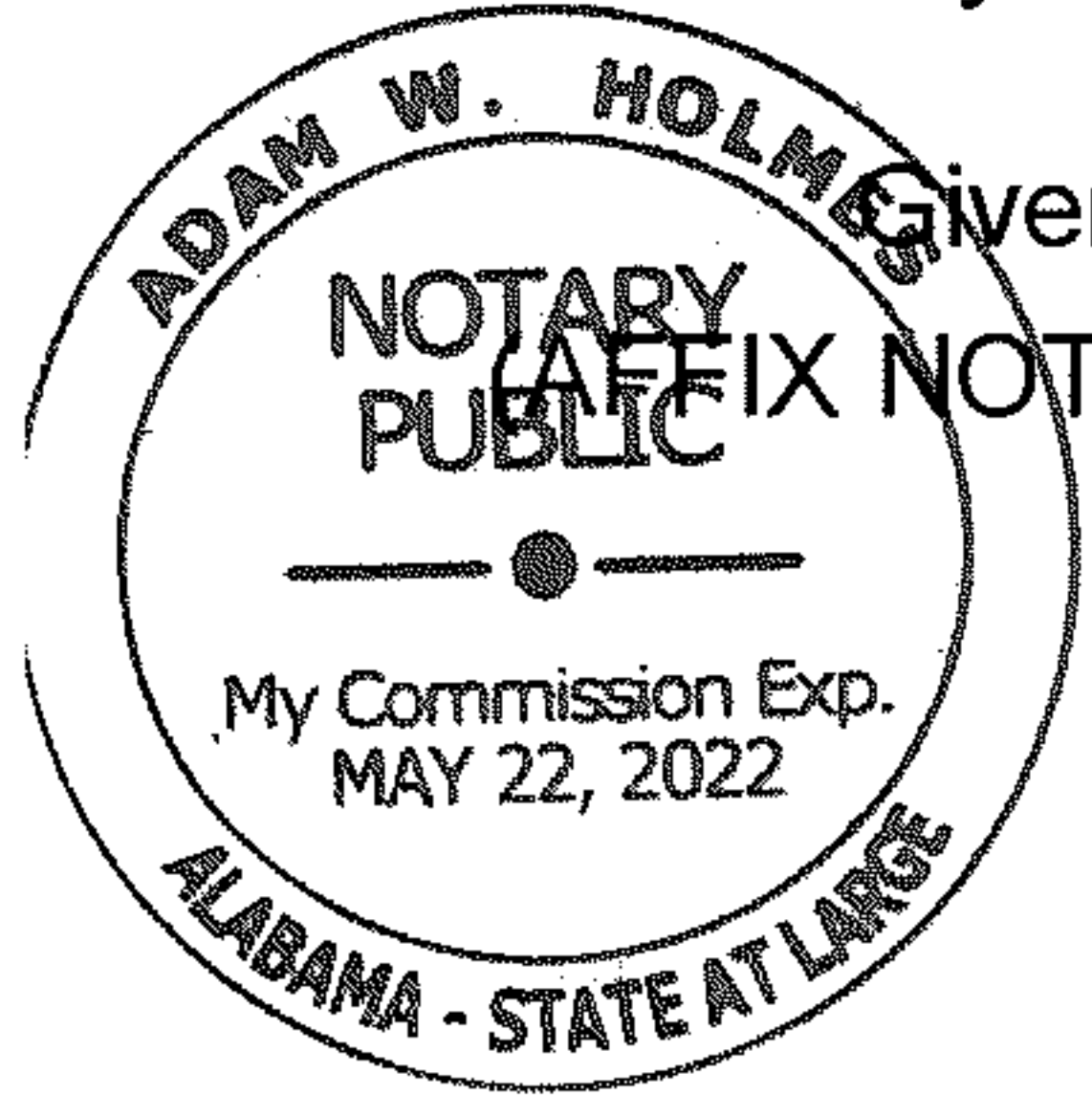
