**ARTICLES OF ORGANIZATION
OF
KEEF CONSTRUCTION, LLC**

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama legislature of the Alabama Limited Liability Company Act ("Act"), the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

**ARTICLE I
Name**

The name of the limited liability company ("Company") is Keef Construction, LLC.

**ARTICLE II
Duration**


The Company shall be dissolved, and its affairs wound up, upon the occurrence of the first of the following events:

- (i) the unanimous written consent of the Members to dissolve the Company;
- (ii) an event of dissociation of a member pursuant to Section 10-12-36 of the Act, unless there are at least two Remaining Members (or at least one Remaining Member and a new Member is admitted) and the legal existence and business of the Company is continued by unanimous consent of the Remaining Members within ninety (90) days thereafter;
- (iii) when the Company is not the successor in a merger or a consolidation of the Company with one or more entities; or
- (iv) upon the entry of a decree of judicial dissolution pursuant to Section 10-12-38 of the Act.

ARTICLE III

The purposes for which the Company is formed are as follows:

- (a) To engage in a Construction work, clearing land, digging ponds/lakes.
- (b) To use a dump truck to haul dirt, sand, gravel and move equipment.
- (c) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

Management


The Company is to be managed by all members, Freeman Alan Keef and Kimberly Dawn Keef.


ARTICLE VIII


