

TERMINATION OF MEMORANDUM OF LEASE BY YOUNG MEN'S CHRISTIAN ASSOCIATION OF BIRMINGHAM AND SHELBY COUNTY PARK AND RECREATION AUTHORITY

Dated August 29, 2019

WHEREAS, THE SHELBY COUNTY PARK AND RECREATION AUTHORITY, a public corporation organized under the laws of the State of Alabama (the "Authority"), the YOUNG MEN'S CHRISTIAN ASSOCIATION OF BIRMINGHAM, a nonprofit corporation organized under the laws of the State of Alabama (the "YMCA"), along with Compass Mortgage Corporation, have entered into Financing and Lease Agreement dated August 12, 2012, as amended by that certain First Amendment to Financing and Lease Agreement dated January 31, 2017 (as amended, the "Existing Financing Agreement"), pursuant to which the Authority leased to the YMCA facilities for the health and wellness of families and individuals (the "Facilities");

WHEREAS, pursuant to the authority of Section 35-4-51.1 of the Code of Alabama 1974 and in lieu of recording the Existing Financing Agreement, the Authority and the YMCA recorded that certain Memorandum of Lease, recorded as Instrument Number 20120905000334830 in the Office of the Judge of Probate of Shelby County (the "Memorandum of Lease");

WHEREAS, pursuant to the Existing Financing Agreement, the Authority issued its Revenue Bond (YMCA Project – Alabaster Branch), (the "Bond") and made the proceeds thereof available to the YMCA in order to refinance the Facilities, and the YMCA agreed to make rental payments to the Authority sufficient to pay, among other things, all debt service on the Bond;

WHEREAS, pursuant to that certain Financing Agreement dated August 29, 2019, by and among the YMCA, the Jefferson County Park and Recreation Board of Jefferson County (the "Park Board") and Regions Capital Advantage, Inc. and that certain Financing Agreement dated August 29, 2019, by and among the YMCA, the Park Board and STI Institutional & Government, Inc., the Park Board has issued its Series 2019 Bonds on behalf of the YMCA for the purpose, among other things, of refinancing the Bond; and

WHEREAS, pursuant to the Existing Financing Agreement, the YMCA has the option to purchase the Facilities upon the payment and defeasance of the Bond, and the YMCA has elected to exercise said option.

NOW, THEREFORE, the Authority and the YMCA do hereby terminate the Memorandum of Lease Agreement, effective on and as of August 29, 2019.
