FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of March, 2011, James Brandon Jones, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Southfirst Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20110414000115180, said mortgage having subsequently been transferred and assigned to Lakeview Loan Servicing, LLC, by instrument recorded in Instrument No. 20190111000012200, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, on September 10, 2019, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and Lakeview Loan Servicing, LLC did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, BHM Capital LLC was the highest bidder and best bidder in the amount of One Hundred Two Thousand And 00/100 Dollars (\$102,000.00) on the indebtedness secured by said mortgage, the said Lakeview Loan Servicing, LLC, by and through Sirote & Permutt, P.C., as attorney for said Transferee, does hereby remise, release, quit claim and convey unto BHM Capital LLC all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:

The property is being conveyed herein on an "as is, where is" basis subject to any easements, encumbrances, and exceptions reflected in the mortgage and those contained in the records of the Office of the Judge of Probate of the county where the above described property is situated; and furthermore, this property is being conveyed without warranty or recourse, express or implied, as to title, use and/or enjoyment and will be subject to the right of redemption of all parties entitled thereto; and by accepting this deed, Grantee releases any and all claims whatsoever against the law firm representing the Grantor hereunder and the auctioneer conducting said foreclosure sale; and furthermore, this conveyance is subject to being declared null and void in the event that the owner or a party claiming through the owner has filed a bankruptcy prior to the date of this foreclosure sale.

encumbrances, recorded or unrecorded easements, liens, taxes, assessments, rights-of-way, and other matters of record in the aforesaid Probate Office.


