## **WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

That in consideration of **Three Hundred Thirty Four Thousand Nine Hundred and 00/100 Dollars (\$334,900.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

**H. Mitchell Howes, and his wife, Linda L. Howes**

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**James L. Merriwether, Jr. and Pansy F. Merriwether**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:

**Lot 183, according to the Survey of Phase One Caldwell Crossings 2nd Sector, as recorded in Map Book 30, Page 116, in the Probate Office of Shelby County, Alabama.**

Subject to: (1) 2019 ad valorem taxes not yet due and payable;  
(2) all mineral and mining rights not owned by the Grantors; and  
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.






