

ARTICLES OF ORGANIZATION OF BCNB MANAGEMENT, LLC

The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under the Alabama Limited Liability Company Law of 2014, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

BCNB MANAGEMENT, LLC

SECOND: The term of existence of the Limited Liability Company shall be perpetual, unless the Limited Liability Company is sooner terminated by the occurrence of an event set forth in the Operating Agreement.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Alabama Limited Liability Company Law of 2014, including all powers and purposes now and hereafter permitted by law to a limited liability company.

SIXTH: The Limited Liability Company is to be managed by the Managing Members. The names and addresses of the initial Managing Members are: WILLIAM BLUE AKERS, having an address at 1029 South Hampton Place, Birmingham, AL 35242, and NICOLE LYN AKERS, having an address at 1029 South Hampton Place, Birmingham, AL 35242 The foregoing Managing Members shall serve as Managing Members until the first annual meeting of the Members or until their successors are duly appointed.

SEVENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the affirmative vote or consent of Members holding two-thirds of the Members' Percentage Interests, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

EIGHTH: The remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Managing Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

TWELFTH: The Limited Liability Company does not have the power to expel a Member.

THIRTEENTH: No the Members or parties to a contribution agreement or a contribution allowance agreement have preemptive rights.

FOURTEENTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.


