FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of October, 2006, Susane Parson and James Parson a married couple, executed that certain mortgage on real property hereinafter described to CitiFinancial Corporation, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20061031000536320, said mortgage having subsequently been transferred and assigned to Towd Point Mortgage Trust 2017-6, U.S. Bank National Association, as Indenture Trustee, by instrument recorded in Instrument number 20190408000111940, in the aforesaid Probate Office ("Transferee"); and

general circulation published in Shelby County, Alabama, in its issues of July 17, 2019, July 24, 2019, and July 31, 2019; and

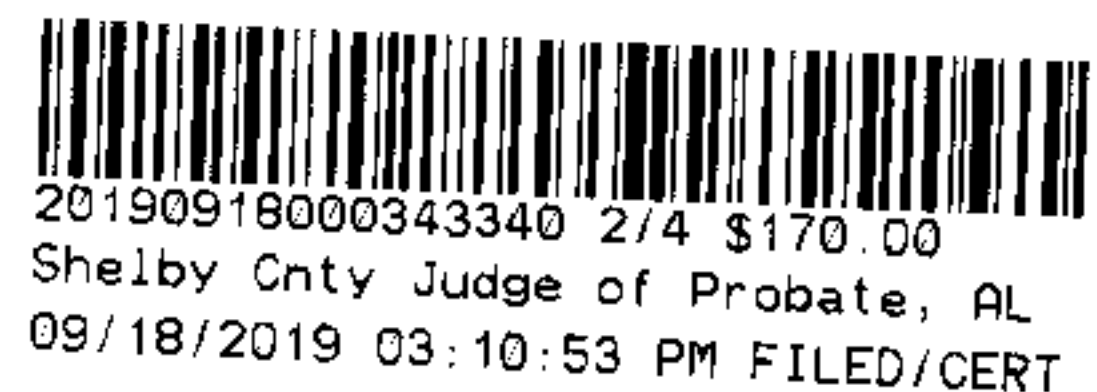

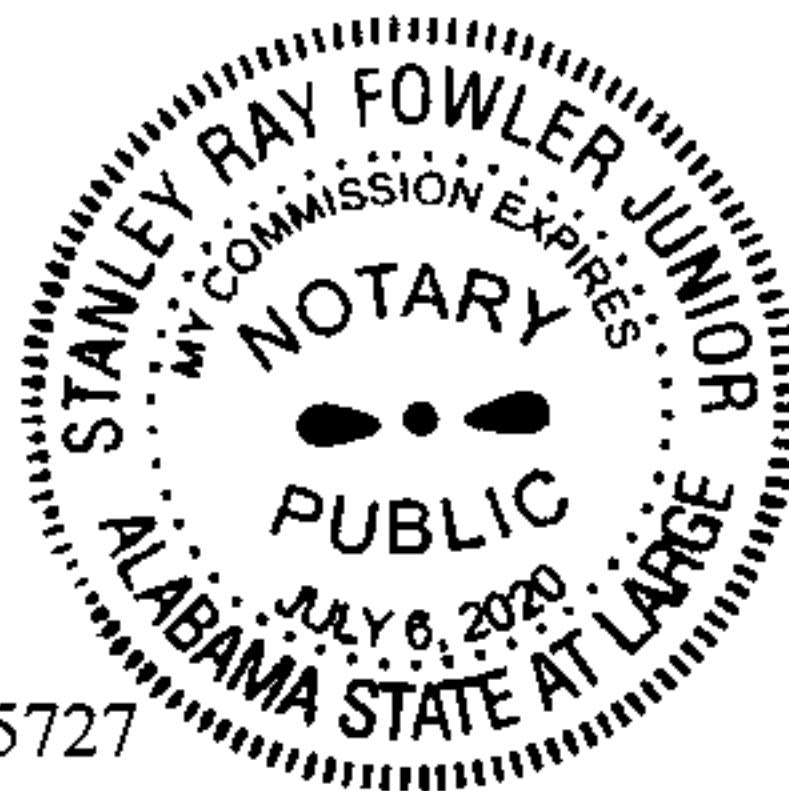
