MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, October 30, 2017, **Elijah G. Logan, Husband and Jamie L. Logan, Wife, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc., as mortgagee, as nominee for HomeServices Lending, LLC, its successors and assigns**, which said mortgage is recorded in Instrument No. 20171102000397370, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to **Nationstar Mortgage LLC d/b/a Mr. Cooper**, as transferee, said transfer is recorded in Instrument 20190730000273480, aforesaid records, and Nationstar Mortgage LLC d/b/a Mr. Cooper, is now the holder and owner of said mortgage and debt; and

WHEREAS, on September 9, 2019, the day on which the foreclosure sale was due to be held under the terms of said notice at 11:37 o'clock am, between the legal hours of sale, said foreclosure was duly and properly conducted and Nationstar Mortgage LLC d/b/a Mr. Cooper did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Sterrett, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of Nationstar Mortgage LLC d/b/a Mr. Cooper in the amount of **ONE HUNDRED SIXTY-SIX THOUSAND FOUR HUNDRED NINETEEN DOLLARS AND NO CENTS (\$166,419.00)** which sum the said Nationstar Mortgage LLC d/b/a Mr. Cooper offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Nationstar Mortgage LLC d/b/a Mr. Cooper; and

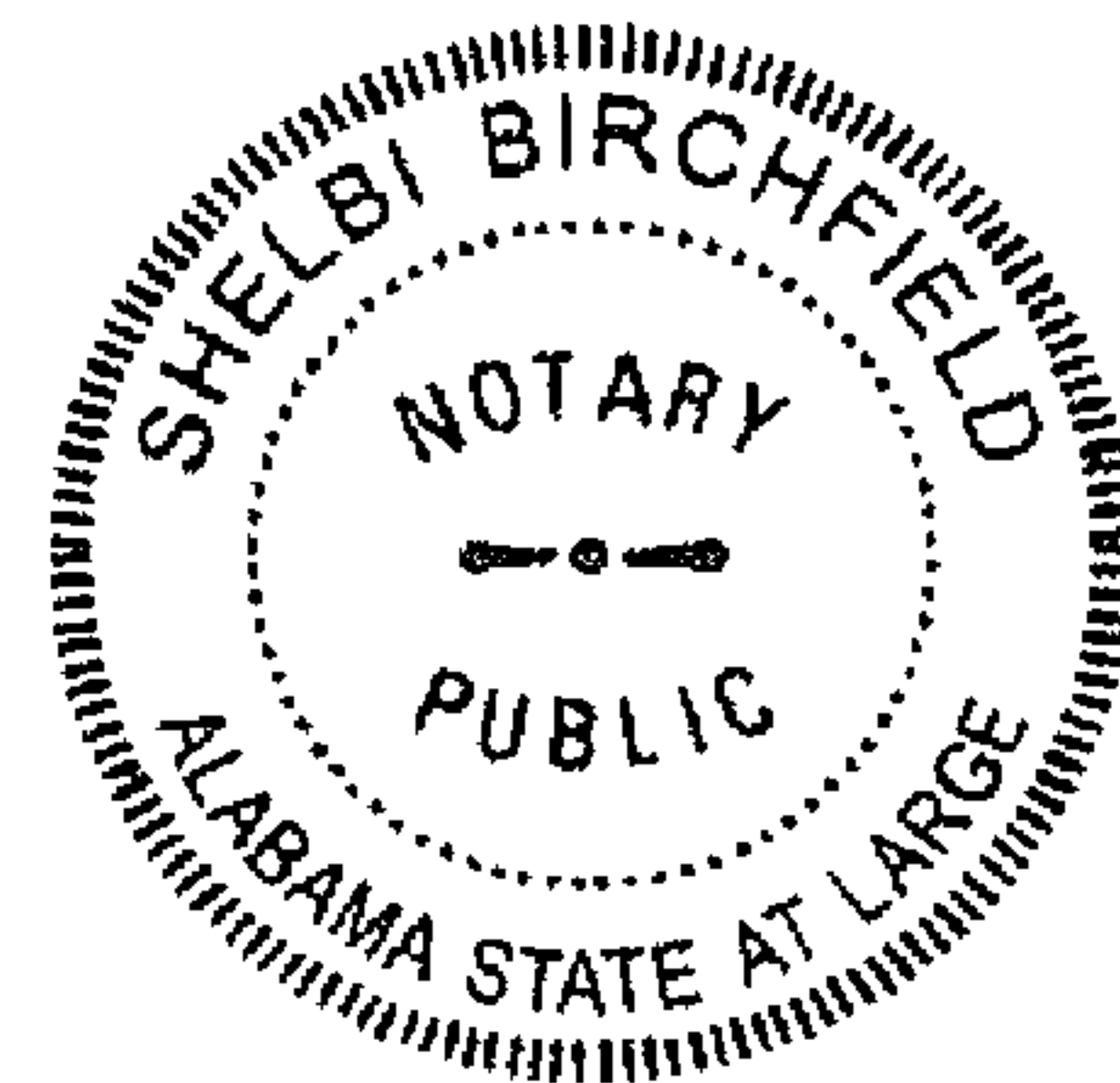
