FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of May, 2007, Robert G. Holston, Jr., a married man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Lehman Brothers Bank, FSB, a Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070531000252510, said mortgage having subsequently been transferred and assigned to Wilmington Savings Fund Society, FSB, d/b/a Christiana Trust, not in its individual capacity, but solely as indenture trustee of Citigroup Mortgage Loan Trust 2015-A, by instrument recorded in Instrument number 20190717000255390, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, in and by said mortgage, the Transferee was authorized and empowered in case of default in the payment of the indebtedness secured thereby, according to the terms thereof, to sell said property before the Courthouse door in the City of Columbiana, Shelby County, Alabama, after giving notice of the time, place, and terms of said sale in some newspaper published in said County by publication once a week for three (3) consecutive weeks prior to said sale at public outcry for cash, to the highest bidder, and said mortgage provided that in case of sale under the power and authority contained in same, the Transferee or any person conducting said sale for the Transferee was authorized to execute title to the purchaser at said sale; and it was further provided in and by said mortgage that the Transferee may bid at the sale and purchase said property if the highest bidder thereof; and



WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the said Wilmington Savings Fund Society, FSB, d/b/a Christiana Trust, not in its individual capacity, but solely as indenture trustee of Citigroup Mortgage Loan Trust 2015-A did declare all of the indebtedness secured by said mortgage, subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of August 21, 2019, August 28, 2019, and September 4, 2019; and

WHEREAS, on September 17, 2019, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and Wilmington Savings Fund Society, FSB, d/b/a Christiana Trust, not in its individual capacity, but solely as indenture trustee of Citigroup Mortgage Loan Trust 2015-A did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, Citigroup Mortgage Loan Trust 2015-A was the highest bidder and best bidder in the amount of One Hundred Nineteen Thousand Two Hundred Fifty-Two And 50/100 Dollars (\$119,252.50) on the indebtedness secured by said mortgage, the said Wilmington Savings Fund Society, FSB, d/b/a Christiana Trust, not in its individual capacity, but solely as indenture trustee of Citigroup Mortgage Loan Trust 2015-A, by and through Sirote & Permutt, P.C., as attorney for said Transferee, does hereby grant, bargain, sell and convey unto Citigroup Mortgage Loan Trust 2015-A all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:

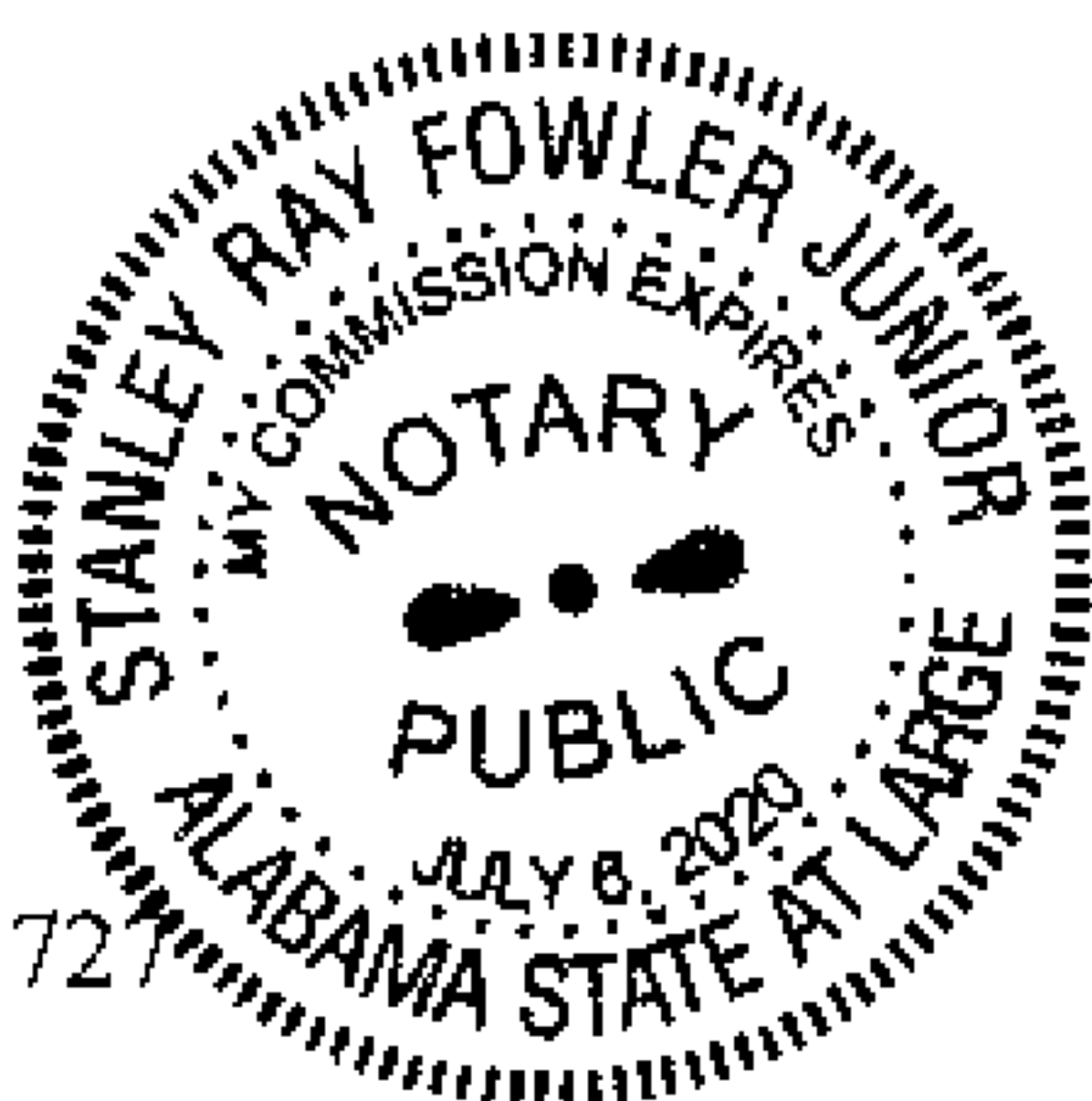

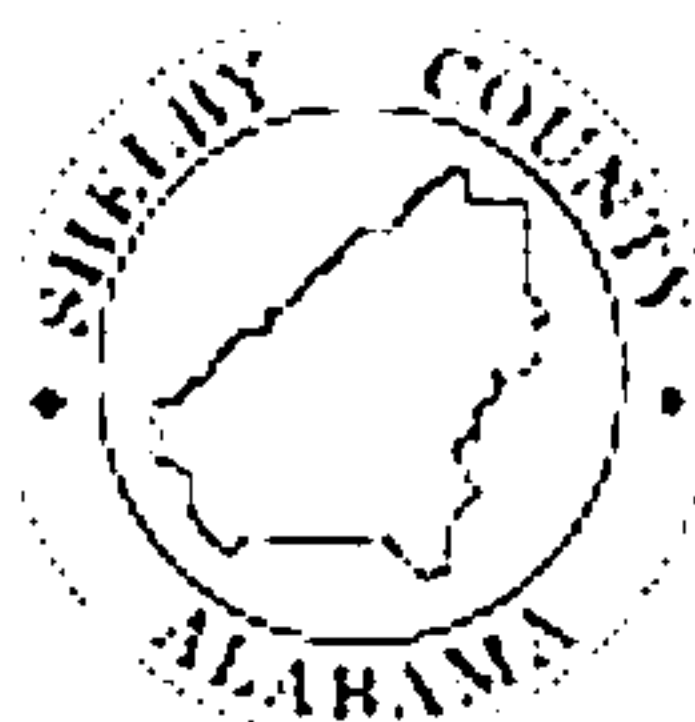
