

**AMENDMENT OF
THE SANCTUARY TRUST FOR SHELBY COUNTY
TO CHANGE THE NAME TO
JESUS WORKS TRUST A SHELBY COUNTY MINISTRY**

THIS AMENDMENT OF THE SANCTUARY TRUST FOR SHELBY COUNTY TO CHANGE THE NAME TO JESUS WORKS TRUST A SHELBY COUNTY MINISTRY (this "Amendment") is made effective as of the 1st day of June, 2017, by the undersigned **WERNER H. BEIERSDOERFER** and **MICHAEL K. FLOWERS** (collectively, the "Trustees"), in their capacities as Co-Trustees of said trust (the "Trust").

The Trustees created the Trust by a trust instrument titled the "**THE SANCTUARY TRUST FOR SHELBY COUNTY**" and dated January 31, 2008.

ARTICLE IV of the Trust authorizes the Trustees to amend the Trust as follows:

This Declaration of Trust may be amended at any time or times by written instrument or instruments signed and sealed by the Trustees, provided that no amendment shall authorize the Trustees to conduct the affairs of the Trust in any manner or for any purpose contrary to the provisions of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The Trustees now to desire to exercise the powers granted under **ARTICLE IV** of the Trust to change the name of the Trust from **THE SANCTUARY TRUST FOR SHELBY COUNTY** to **JESUS WORKS TRUST A SHELBY COUNTY MINISTRY**.

NOW THEREFORE, the Trustees hereby amend the Trust by deleting **ARTICLE I** of the Trust in its entirety and replacing it with the following Article:

**ARTICLE I
NAME OF TRUST**

This trust shall be called "Jesus Works Trust A Shelby County Ministry" (called the "Trust").

The Trustees hereby ratify and confirm the Trust insofar as it is not in conflict with this Amendment.

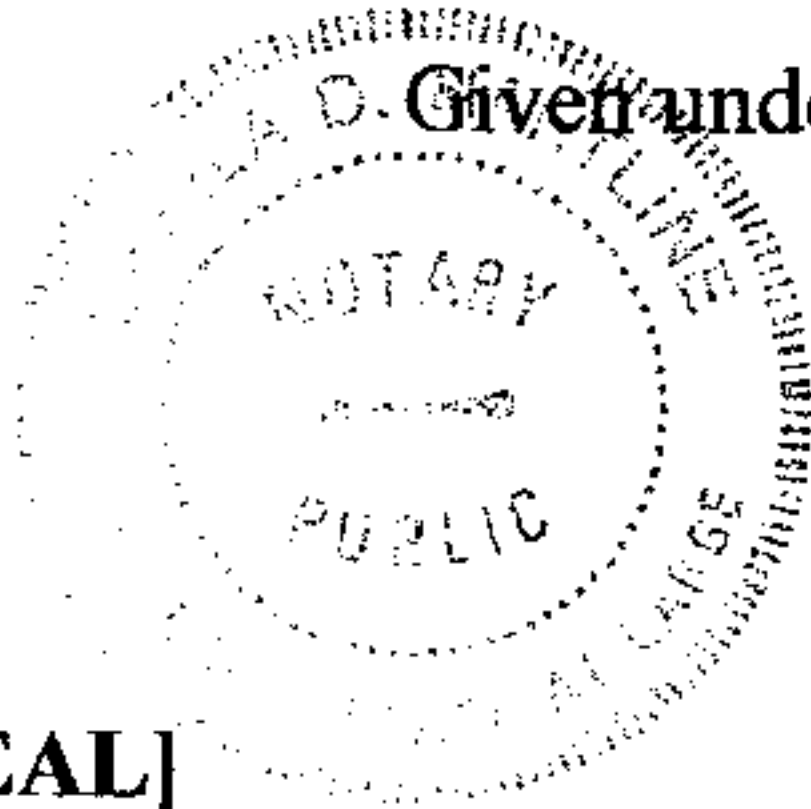
