That in consideration of **Two Hundred Thousand and 00/100 Dollars (\$200,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Iris Nunez Quinn and Matt Lamar Quinn

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 25, according to the Survey of Old Virginia, as recorded in Map Book 7, Page 117, in the Probate Office of Shelby County, Alabama


\$170,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.


