DOMESTIC BUSINESS CORPORATION  
AMENDMENT TO FORMATION/ARTICLES

PURPOSE: In order to amend a Business Corporation's (formerly known as For-Profit Corporation) Certificate of Formation/Articles of Incorporation under Section 10A-2-10.06 of the Code of Alabama 1975 this Amendment and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the corporation's Certificate of Formation was initially filed.

INSTRUCTIONS: Mail one (1) signed original and two (2) copies of this completed form and the appropriate filing fees to the Office of the Judge of Probate in the county where the corporation's Certificate of Formation was recorded. Contact the Judge of Probate's Office to determine the county filing fees. Make a separate check or money order payable to the **Secretary of State for the state filing fee of \$50.00** and the Judge of Probate's Office will transmit the fee along with a certified copy of the Amendment to the Office of the Secretary of State within 10 days after the filing is recorded. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment (see attached). Your filing will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored (\$30.00 fee).

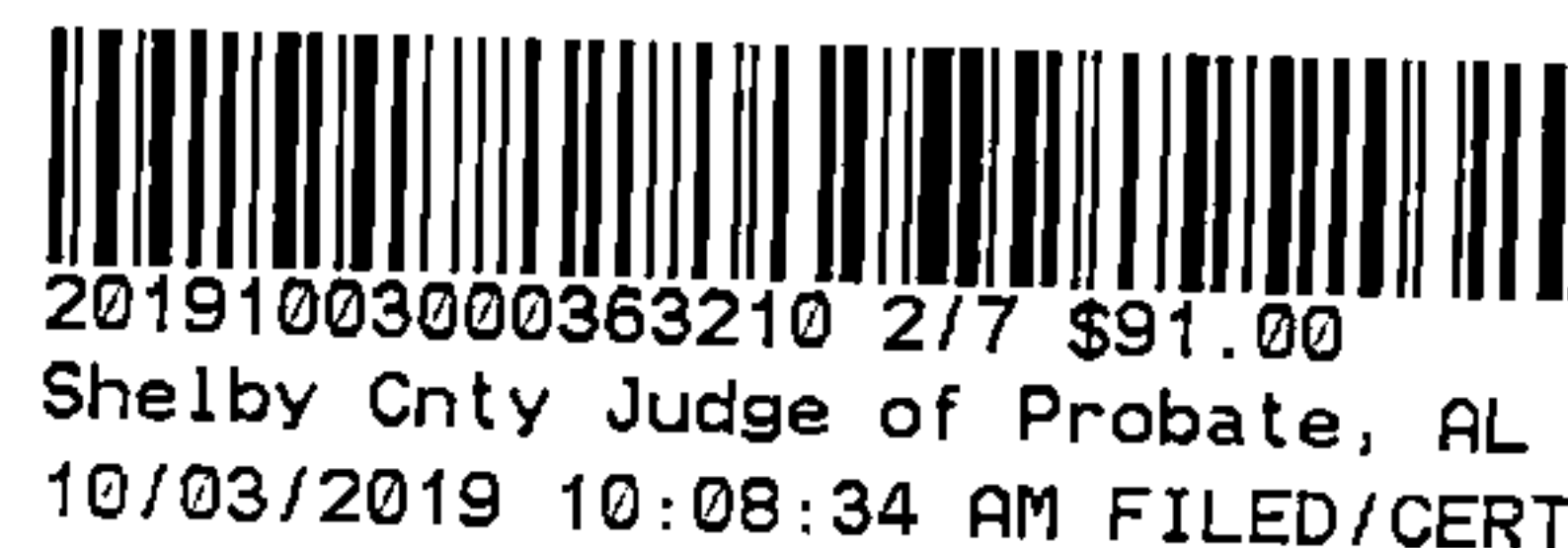

**ARTICLES OF INCORPORATION  
OF  
THE FARR FAMILY CEMETERY**

The undersigned acting under the authority granted same by the Board of Trustees (Directors) of "The Farr Family Cemetery" located off Highway 25 in Columbiana, Alabama in a duly called and held business meeting with the intent of incorporating "The Farr Family Cemetery," do hereby make, declare and file the following Articles of Incorporation:

**ARTICLE I  
NAME OF INCORPORATION**

The name of the Incorporation is "The Farr Family Cemetery."

**ARTICLE II  
AUTHORITY AND PURPOSE**

The said incorporated cemetery shall have the authority and purpose to perpetuate and enjoy our cemetery: "The Farr Family Cemetery."

The nature of the said corporation is religious and as a religious corporation it shall also have the authority to function as a religious, charitable, benevolent, and educational incorporation, for all members of the society of humanity, individually and collectively, worldwide.

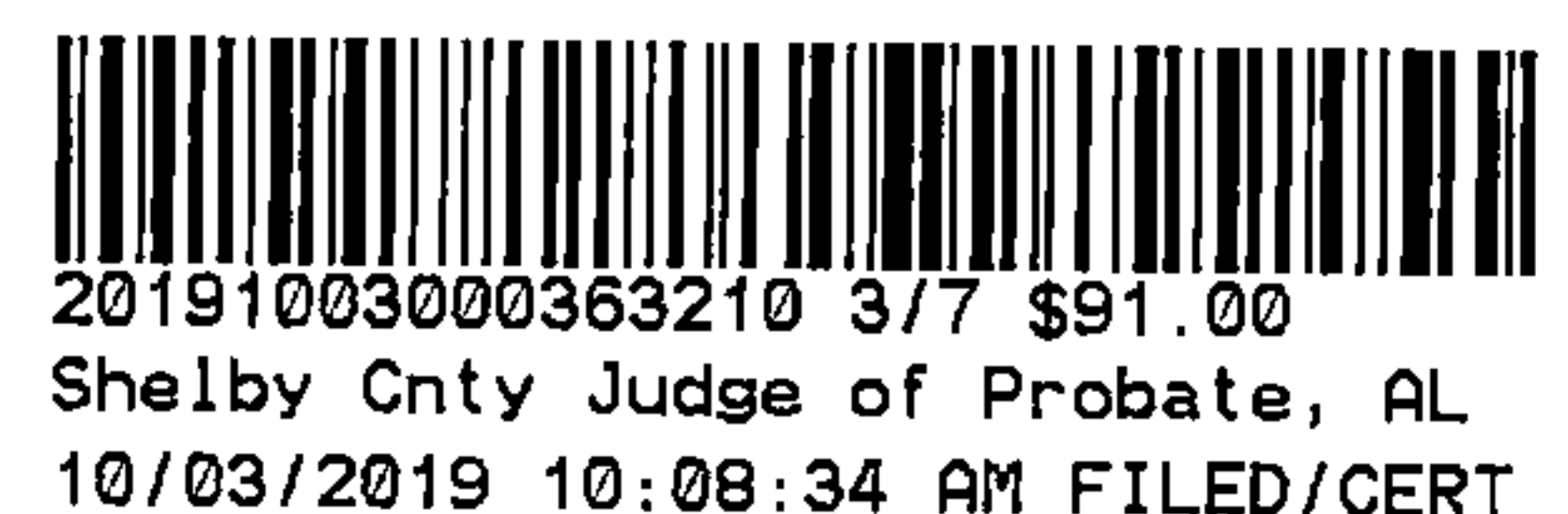
**ARTICLE III  
EXISTENCE**

The existence of this corporation shall be perpetual.

**ARTICLE IV  
ADMINISTRATION OF CEMETERY AFFAIRS**

The material and business affairs of the corporation are to be administered by the following officers of the cemetery under the direction of the Board of Trustees:

1. By a Board of Trustees composed of not less than three nor more than thirteen who shall make and execute all contracts, deeds, bonds, notes, negotiable instrument, mortgages, trusts and all other instruments of indebtedness or conveyance of the incorporated cemetery upon the order therefor, by resolution by the Board of Trustees sitting in a duly called conference, duly adopted for such purposes; provided, however, that all such documents be signed for and on behalf of the Board of Trustees by any three of the members of the Board of Directors.
2. The offices of the Board of Trustees shall be at least the president of the board, first vice-president, secretary and treasurer, and any other office of the board, with the board's concurrence.



3. The Title of all property shall be vested in the name of said incorporated cemetery.
4. The Board of Trustees shall have such other duties and authority as provided by the Bylaws of the cemetery.
5. It shall be the responsibility of the Board of Trustees to provide for the use, maintenance, preservation, and care of all cemetery property.

#### **ARTICLE V MEMBERSHIP OF THE BOARD OF TRUSTEES**

The Bylaws as established the Board of Trustees will set forth the method to determine the number and nature of membership of the Board of Trustees, and Directors of the incorporated cemetery. However, there must be at least three (3) members of the Board of Trustees and the Directors.

#### **ARTICLE VI CEMETERY BUSINESS MEETING**

The business meeting may be held on any specifically scheduled and publicized business meeting date. The Bylaws of same shall provide for regularly scheduled meetings, publication for the transaction of business, ad for the calling of special meetings, call for the transaction of the special business. The quorum required for the transactions shall be provided in the Bylaws of the incorporated cemetery,

#### **ARTICLE VII BYLAWS**

Bylaws of the cemetery may be adopted by majority vote of those Board of Trustees present and voting when the Board is sitting in duly called and held conference. The Bylaws may be amended, altered or receded by the Board of Trustees sitting in conference.

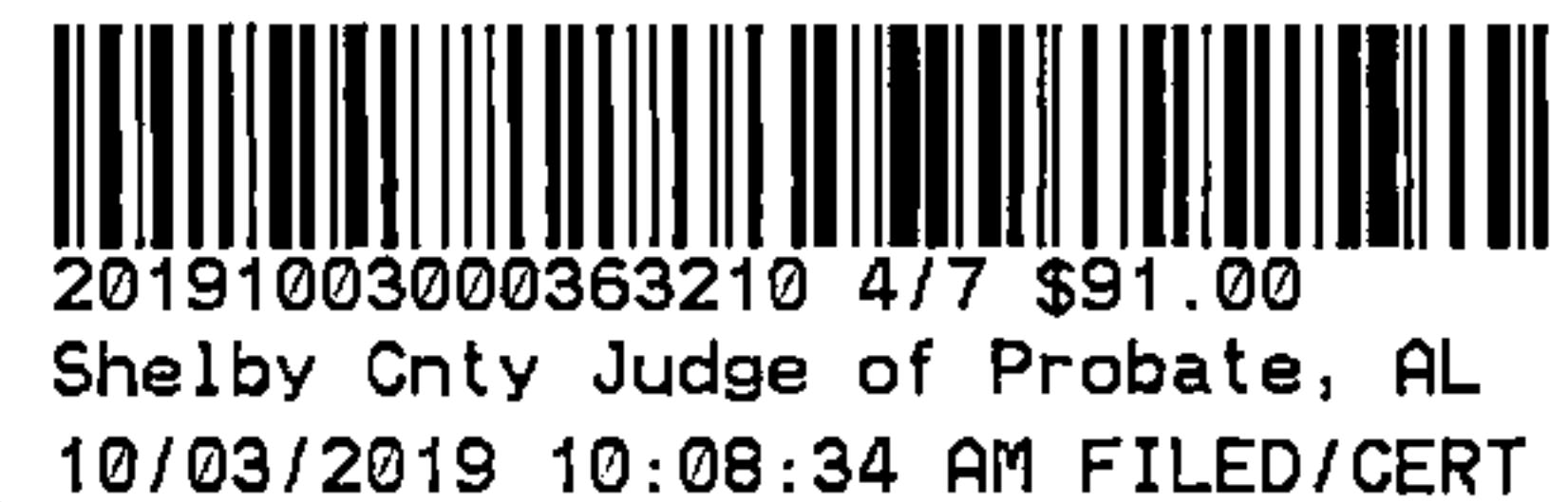
#### **ARTICLE VIII AMENDMENTS TO ARTICLES OF INCORPORATION**

The Articles of Incorporation may be amended by a two-thirds (2/3) vote of those present and voting when the Board of Trustees is sitting in a duly called and held conference as provided ty its Bylaws.

#### **ARTICLE IX ELECTIONS**

Elections shall be held at such time and in such a manner as designated in the Bylaws; regular elections shall occur annually, unless provided for differently. Special elections may occur more frequently.

Members of the Board of Trustees shall serve as long as he/she desires, except when majority of the Board deems a Director should be replaced. The qualification of trustees shall be prescribed in the Bylaws.



**All Trustees and committee persons shall hold office until their successors are duly elected and take office.**

**ARTICLE X  
CEMETERY YEAR**

**The cemetery year shall extend from the first day of May through the following April for a period of twelve months, and each twelve month period thereafter.**

**ARTICLE XI  
DISCHARGE OF TRUSTEES, OFFICERS, AND COMMITTEE PERSONS**

**Any Trustee (Director), Officer, or Committee person may be discharged by a majority vote of the Board of Trustees sitting in a duly called and held conference for any cause deemed advisable; provided, however, any trustee, officer or committee member shall be given an opportunity to defend himself either or during such conference. Further details may be set out in the Bylaws of the cemetery.**

**ARTICLE XII  
TRANSFER OF ASSETS IN THE EVENT OF DISSOLUTION**

**If this corporation shall ever be dissolved, all of its assets remaining after payment and satisfaction of all its costs, and indebtedness, including the expense of such dissolution, shall be distributed to non-profit corporations, or another organization, which is qualified for exemption under Section 501©(3) of the Internal Revenue Code of any successor to said Section.**

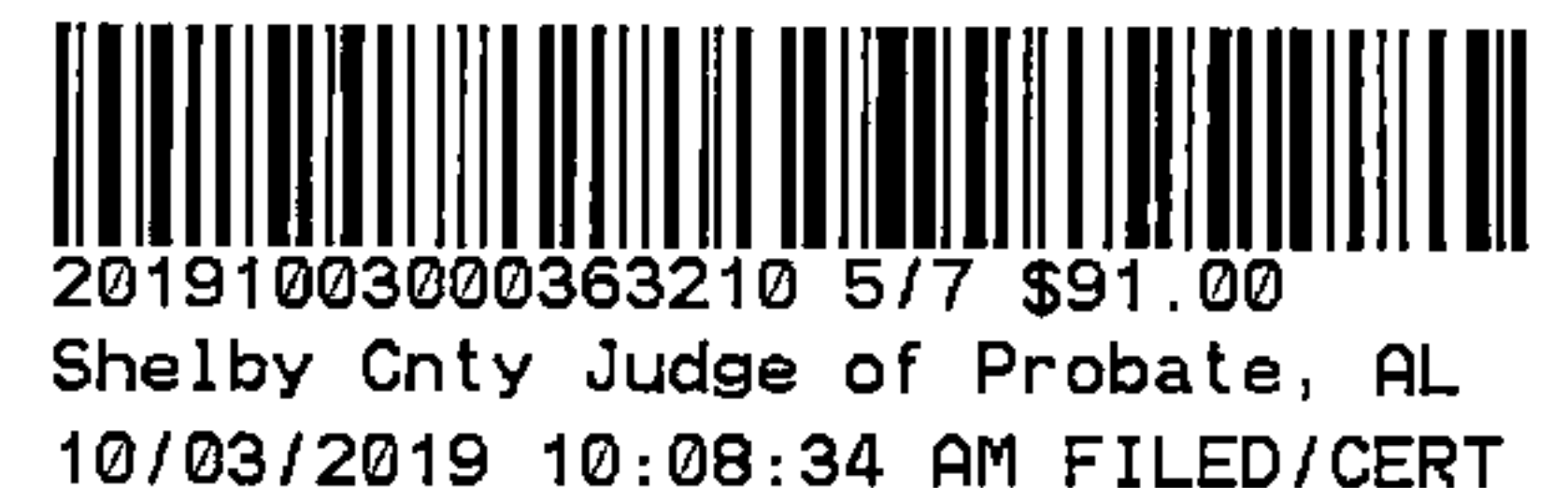
**The members of the Board of Trustees in good standing at the time of dissolution of said corporation shall, in a duly called conference sitting, designate the non-profit corporation(s) or organization(s) to receive assets of the corporation upon dissolution. No substantial assets of said cemetery shall be distributed to any member of trustee of this cemetery.**

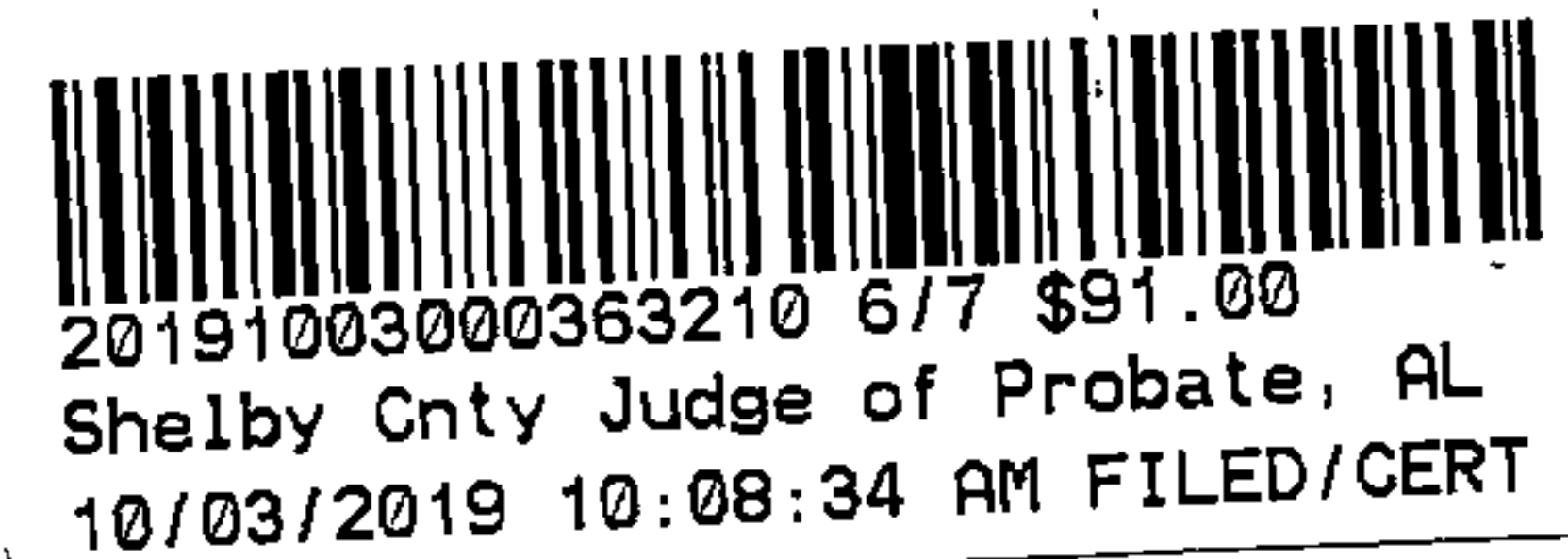


