The name and address of the initial registered agent of the Company shall be John Wolsoncroft, at 2017 Highland Village Bend, Birmingham, Alabama 35242.



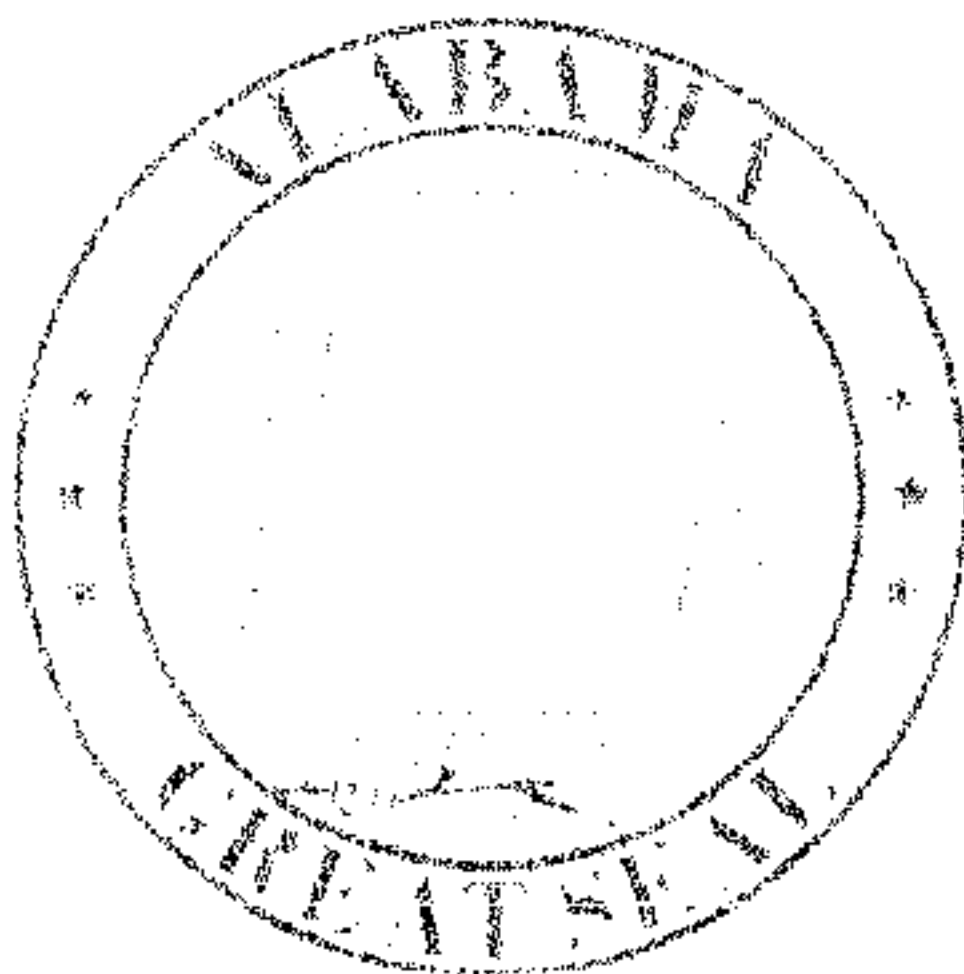
