DURABLE POWER OF ATTORNEY

I do hereby revoke any and all powers of attorney heretofore executed by me to any person or persons whatever.

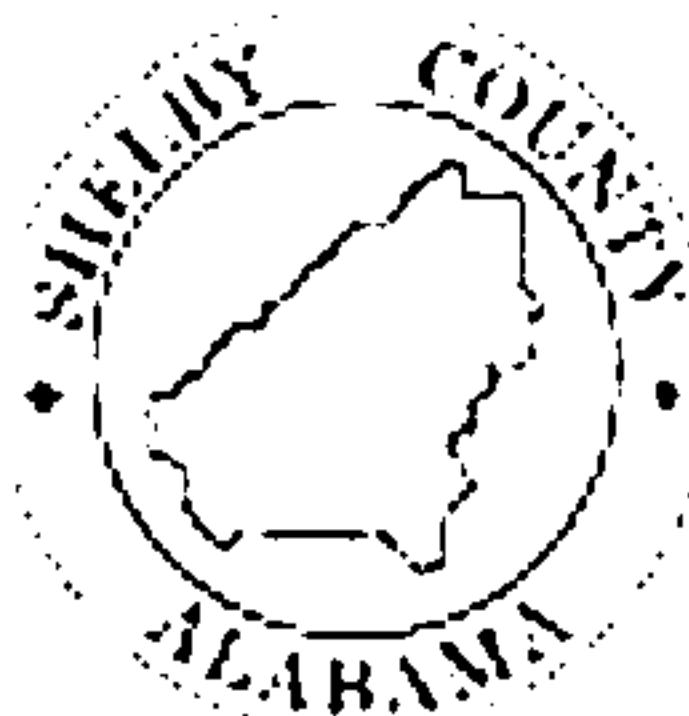
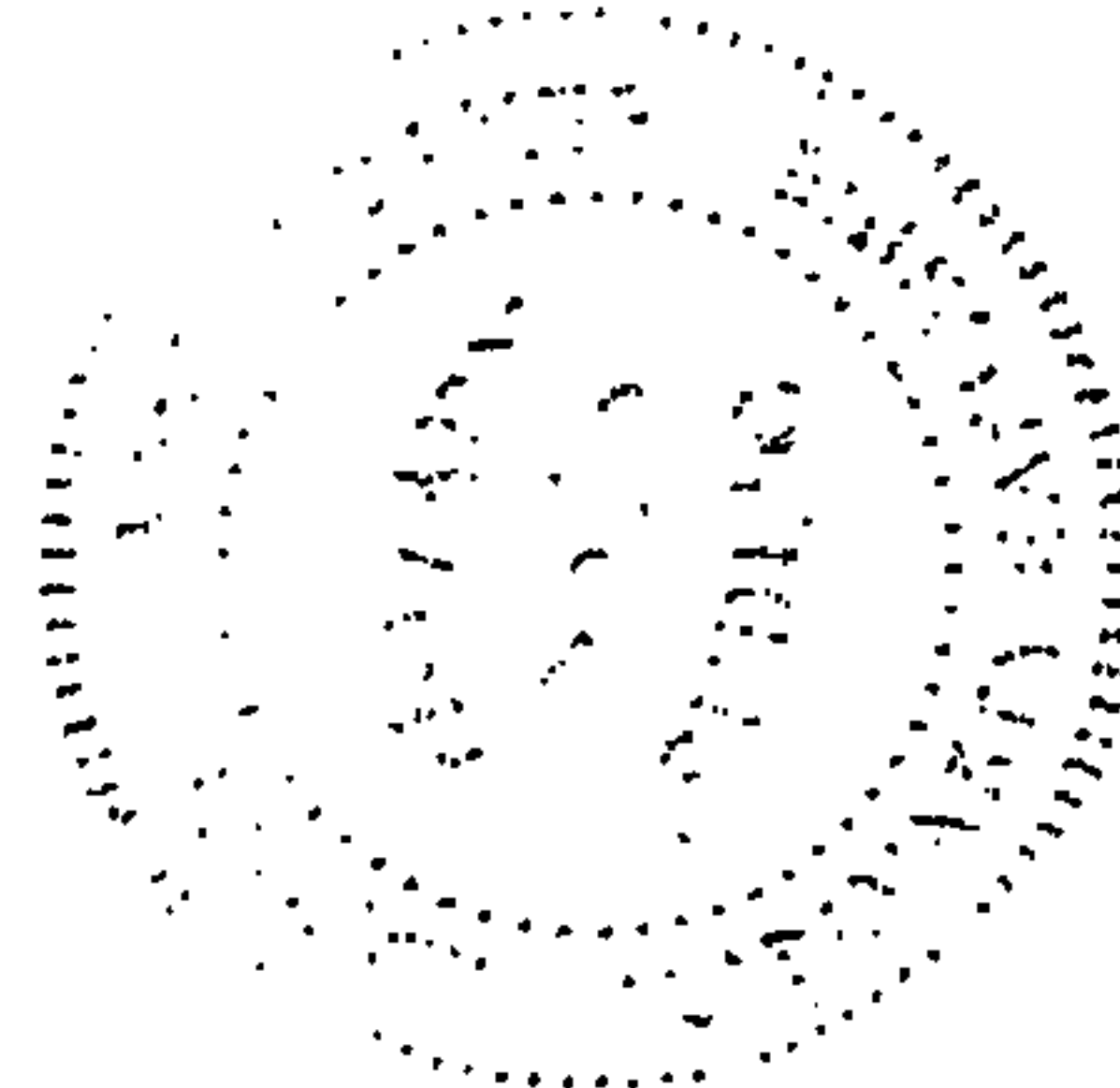
