FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of September, 2009, Kathryn W. Pettit, an unmarried person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Compass Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20091009000382690; along with Affidavit of Fact in Instrument Number 20190717000255100, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC d/b/a Mr. Cooper, by instrument recorded in Instrument No. 20171005000364160, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, BHM Capital, LLC was the highest bidder and best bidder in the amount of Seventy-Nine Thousand Forty-One And 00/100 Dollars (\$79,041.00) on the indebtedness secured by said mortgage, the said Nationstar Mortgage LLC d/b/a Mr. Cooper, by and through Sirote & Permutt, P.C., as attorney for said Transferee, does hereby remise, release, quit claim and convey unto BHM Capital, LLC all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:

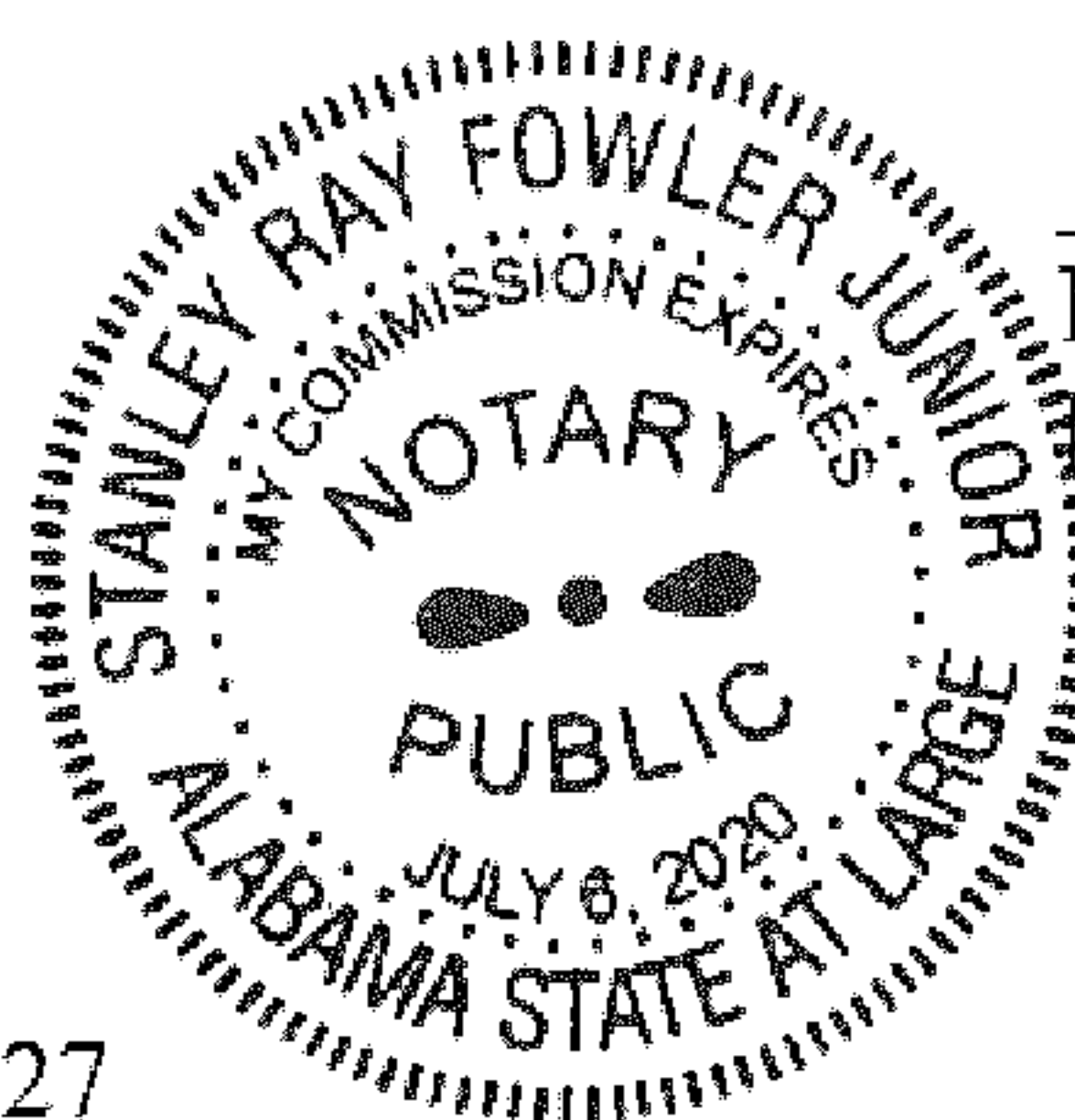
