FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of September, 2006, Curtiss Hipps and Terri Hipps, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for The Mortgage Outlet, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060927000480070, said mortgage having subsequently been transferred and assigned to U.S. Bank Trust, N.A., as Trustee for LSF10 Master Participation Trust, by instrument recorded in Instrument number 20190808000286750, in the aforesaid Probate Office ("Transferee"); and

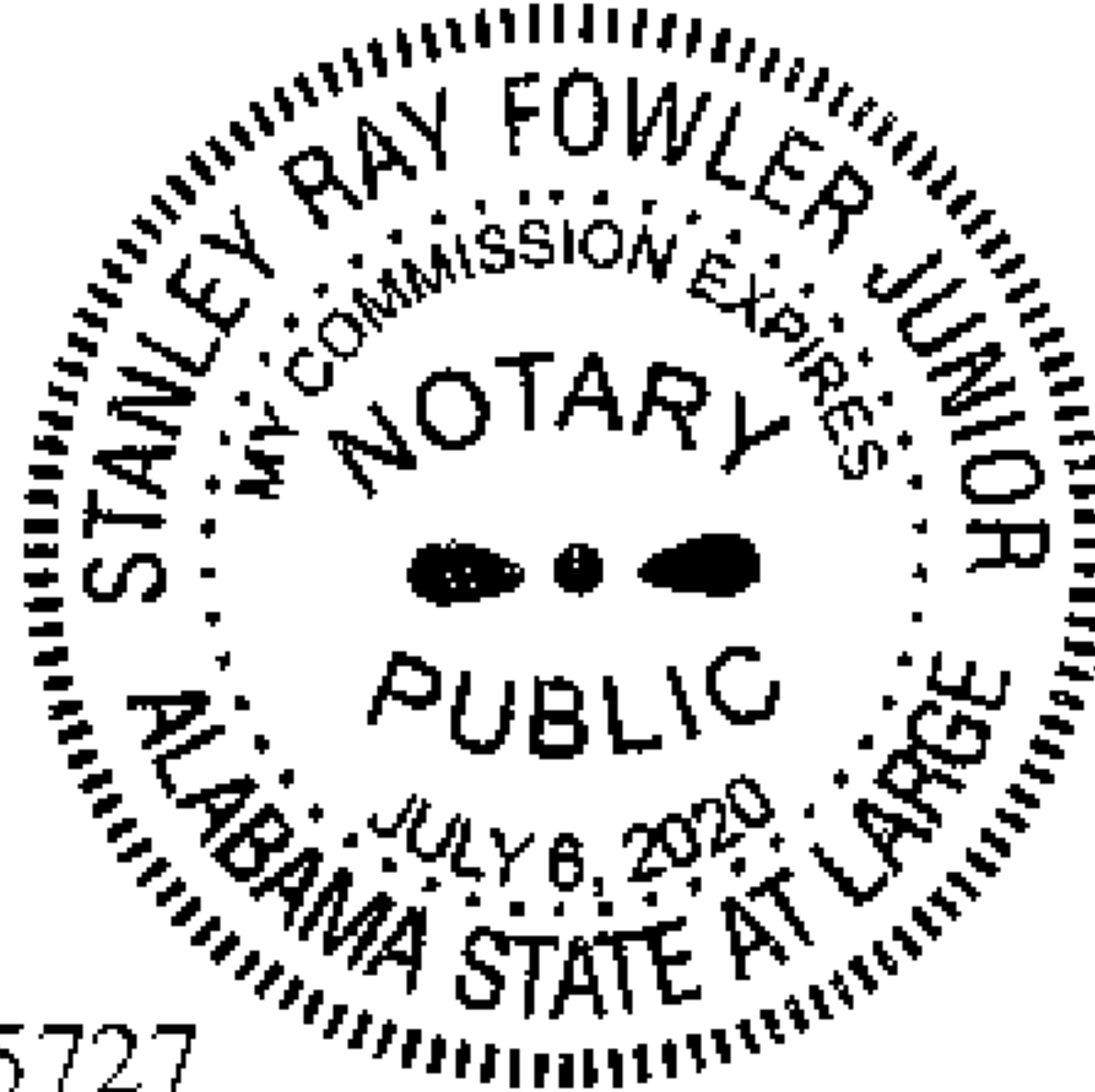
