The water works and distribution system and gas distribution system owned and operated by the Board includes all plants, systems, buildings, facilities or properties used or useful in or having the present capacity for future use in connection with the production, supply or distribution of water and gas and any integral part thereof, and all appurtenances, equipment, properties, rights, easements, permits, licenses, and franchises relating thereto, and all other property, real, personal or mixed, now owned by the Board or hereafter acquired by it, by construction or otherwise, and used in connection with the aforesaid facilities.

3. The Series 2019 Bonds are issued in registered form, in the denomination of \$5,000 each or any integral multiple thereof, bearing interest at the per annum rates set forth below, first interest payable on March 1, 2020, and the first day of each March and September thereafter, and maturing or subject to mandatory redemption on September 1 in accordance with the following schedule:
