

ARTICLES OF ORGANIZATION OF STEEL CITY STRETCH, LLC

The undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is Steel City Stretch, LLC.

The period of duration is perpetual.

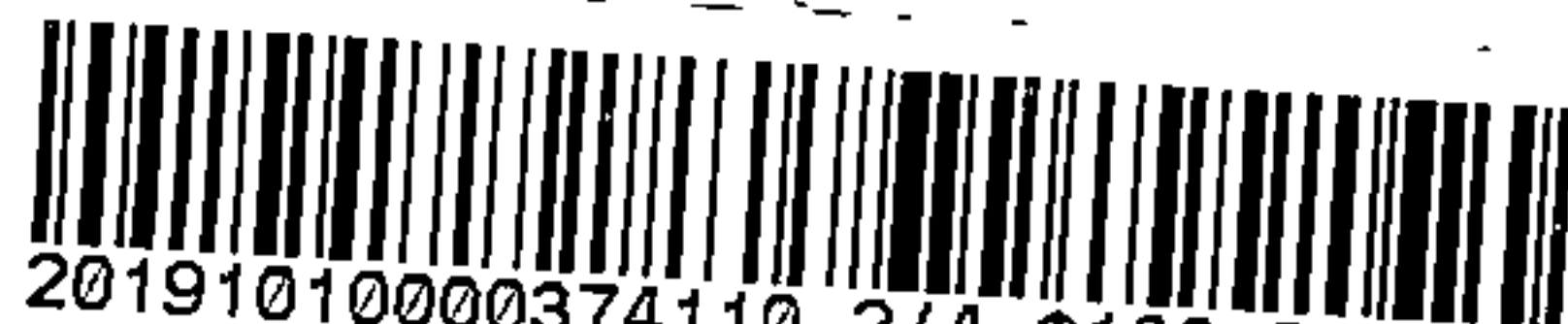
