

ARTICLES OF ORGANIZATION

OF

STEEL CITY STRETCH, LLC

The undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is Steel City Stretch, LLC.

ARTICLE II

DURATION

The period of duration is perpetual.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

1. To engage in the business of practitioner assisted stretching and flexibility training; and
2. The transaction of any or all lawful business which may be incidental or beneficial to the company.





