**On this October 15, 2019,** That for and in consideration of **FOUR HUNDRED TWENTY TWO THOUSAND AND NO/100 (\$422,000.00) DOLLARS,** and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **STACEY BROOKS (BEING THE SAME AS STACEY R. BROOKS) and RANDY BROOKS, wife and husband,** (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **MARY R. POTTS and JAMES G. POTTS,** (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA,** to wit:

Lot 42, according to the Survey of Forest Meadows, 1st Sector, as recorded in Map Book 19, Page 80, in the Office of the Judge of Probate for Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to:

6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 19, Page 80.



The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


