## FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on August 25, 2010, to-wit: Rocelius Custard and Lawanda D. Custard, husband and wife, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for DHI Mortgage Company LTD, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on September 15, 2010, in Instrument No. 20100915000300990 and modified by that certain Loan Modification Agreement recorded on June 23, 2016, in Instrument No. 20160623000218150, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded October 29, 2012, in Instrument No. 20121029000414420, Probate Records of Shelby County, Alabama; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and thereafter notice was published in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on August 21, 2019, August 28, 2019, and September 4, 2019, that the hereinafter described property would be sold at the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on October 1, 2019, and


