

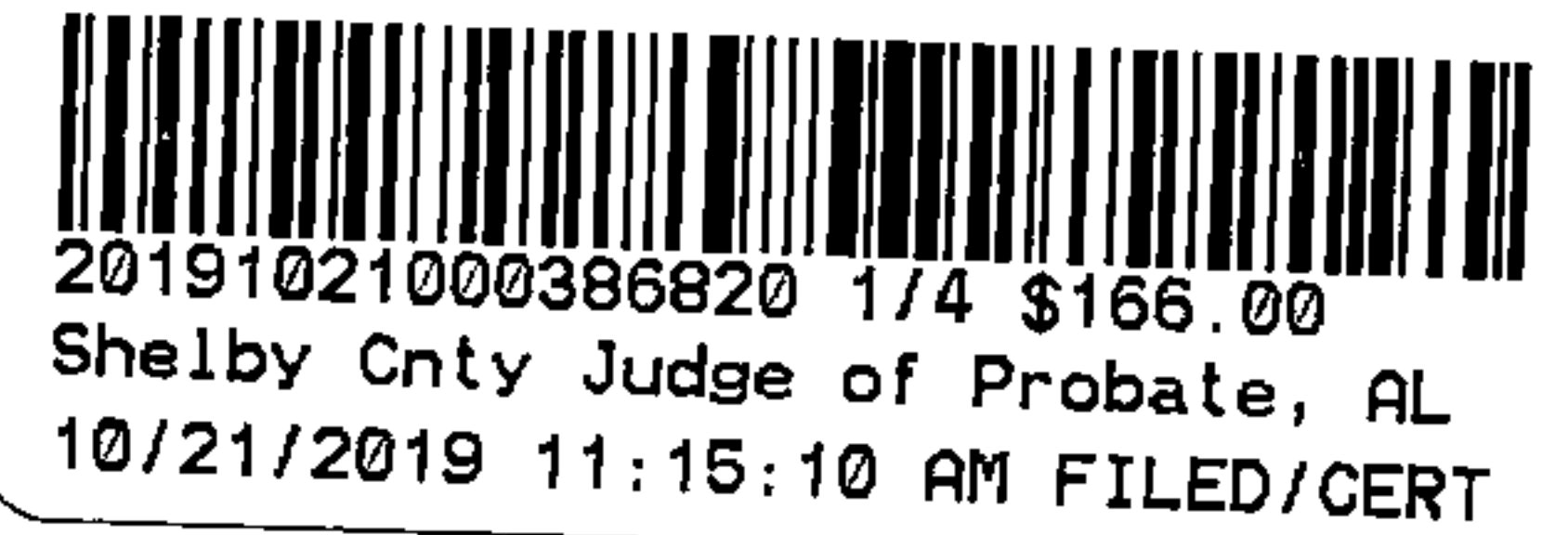

ARTICLES OF ORGANIZATION

The undersigned **Gloria E. Pimentel**, of Shelby County, Alabama, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama (1975) as amended (the "Alabama Limited Company Act"), hereby file the following Articles of organization with the probate judge of Shelby County, the county in which the initial registered office of the limited company will be located and attest that facts stated in these Articles of Organization are true and correct.

ARTICLE I

NAME

The name of this limited liability (the "Company") shall be **MW PINTOR Y MAS, LLC**.

ARTICLE II

DURATION

The period of duration is perpetual from the date of filing of these Articles of organization with the probate judge of Shelby County, unless the company shall sooner dissolve and its affairs are wound up in accordance with its Articles of Organization or Operating Agreement or extend the duration beyond the above stated term.

ARTICLE III

PURPOSE

The nature of the business of the Company and its objects, purpose and powers are and shall to develop and operate a residential and commercial building painting service business, for profit, income, and appreciation, and to conduct or do any other lawful act or business permitted for the company under the Alabama Limited Company Act.

ARTICLE IV

REGISTERED OFFICE & AGENT

The location and street address of the initial registered office of the Company shall be 1480 Kelly Dr., Pelham AL 35124 and its mailing address shall be 1480 Kelly Dr, Pelham, AL 35124 and its Registered Agent at such address is Gloria E. Pimentel.

ARTICLE VI

ADDITIONAL MEMBERS

The member reserves the right to admit additional Members upon the unanimous agreement of the Members as to the admission of, and the consideration to be paid, such new Members, and subject to the terms and conditions of the Company's Operating Agreement.

ARTICLE VII

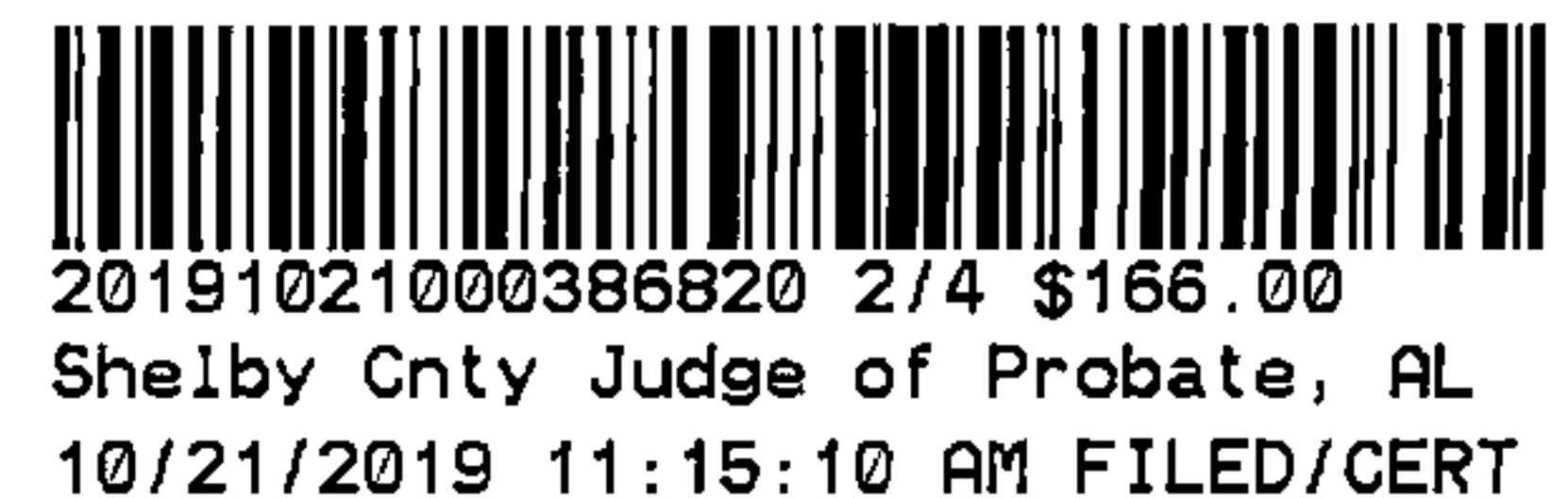
OPERATING AGREEMENT

The Operating Agreement of the company shall be executed by each member of the company and shall set forth all provisions for the affairs of the company and the conduct of its business to the extent that such provisions are not inconsistent with the laws of the United States of America, the state of Alabama, or these Articles of Organization.

ARTICLE VIII

MANAGEMENT

The members shall have the right to continue upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or occurrence of any event which terminated the continued membership of a member in the company (collectively, "Disassociation"), as long as there are at least two remaining members or at least one remaining member and a new member is



admitted, and all remaining members with equity interest agree in writing to continue the company within ninety (90) days after the Disassociation of a member, as set forth in the Operating Agreement of the company.

ARTICLE IX
MANAGEMENT


GLORIA E. PIMENTEL shall be the single member/owner of the company.

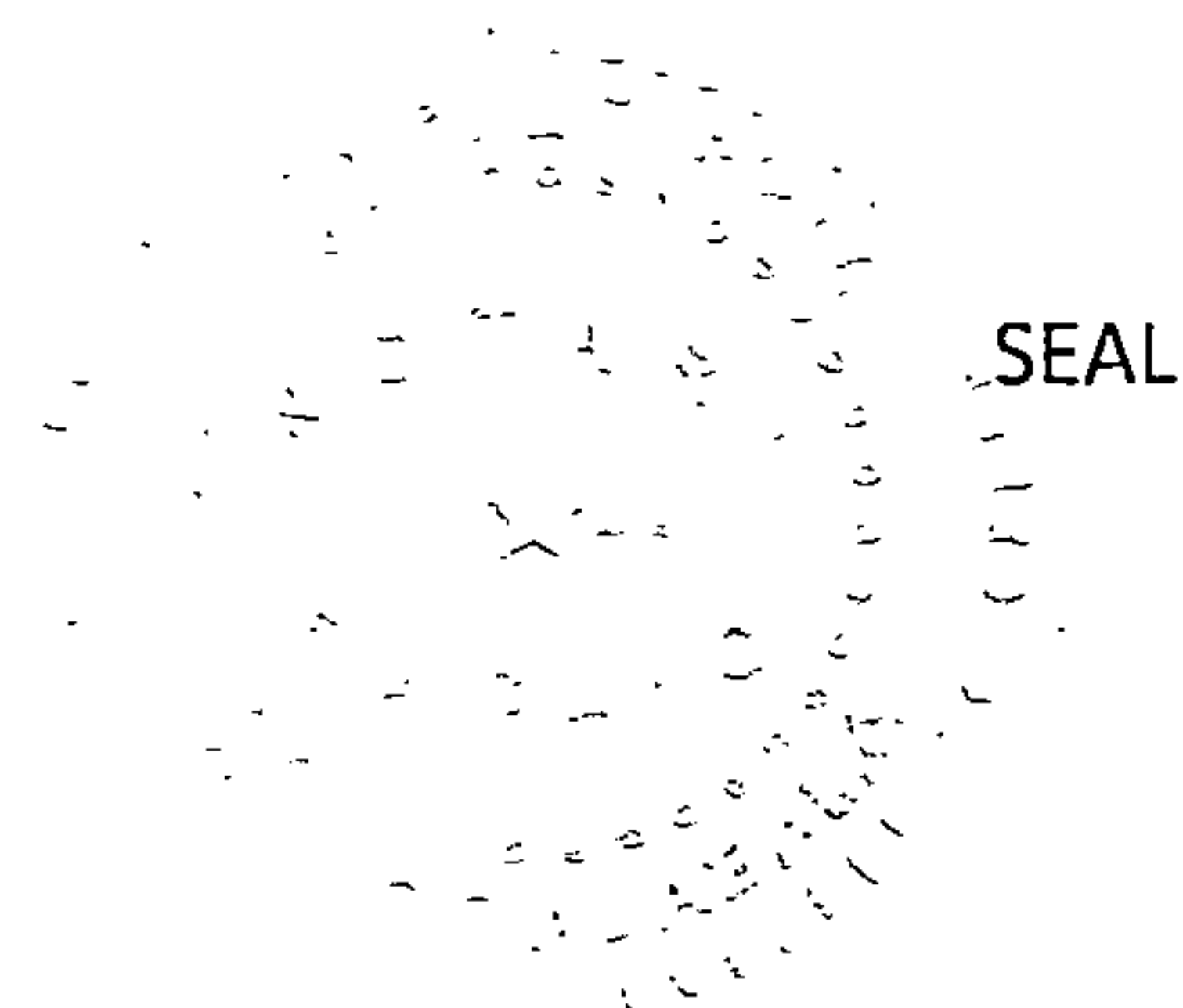
