**On this October 16, 2019**, That for and in consideration of **ONE HUNDRED SEVENTY FOUR THOUSAND NINE HUNDRED AND NO/100 (\$174,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **ESTATE OF BETTY NOLEN GLASS, DECEASED, BY CARLA HILLIARD, AS PERSONAL REPRESENTATIVE (SHELBY COUNTY, ALABAMA PROBATE CASE NO. PR-2019-000246)**, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **BRENDA K. FLEMING**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 6-13, according to the Plat of Chelsea Park 6th Sector, as recorded in Map Book 37, Page 13 in the Probate Office of Shelby County, Alabama.

Together with the nonexclusive easement to use the Common Areas as more particularly described in Declaration of Easements and Master Protective Covenants of Chelsea Park, a Residential Subdivision, executed by the Grantor and filed for record as Instrument No. 20041014000566950 in the Probate Office of Shelby County, Alabama and Declaration of Covenants, Conditions and Restrictions for Chelsea Park 6<sup>th</sup> Sector executed by Grantor and Chelsea Park Residential Association, Inc. and recorded as Instrument No. 2004101400056960 (which, together with all amendments thereto, are hereinafter collectively referred to as the "Declaration").



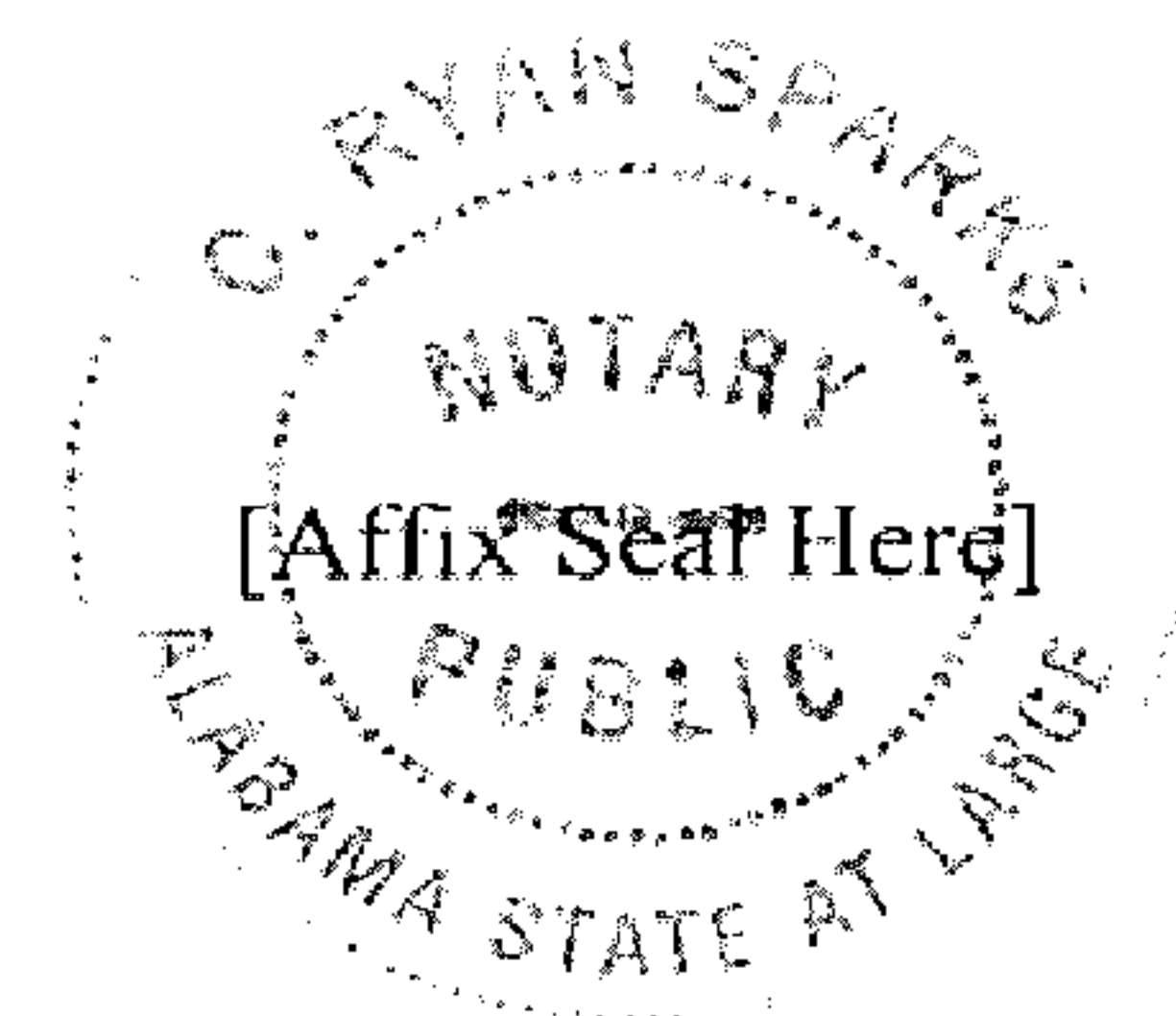
