**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**KNOW ALL MEN BY THESE PRESENTS,**

That for and in consideration of **TWO HUNDRED TWENTY FIVE THOUSAND AND NO/100 (\$225,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **KAMAL A. ALI, an unmarried man and GEORGIA D. MOORE-ALI, an unmarried woman**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **BEATRICE WAITHIRA MURAGE and JOSEPH KAGAI IGUTA**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 157, according to the Survey of Kentwood, Third Addition, Phase Three, as recorded in Map Book 20, Page 79, in the Probate Office of Shelby County, Alabama.

**Subject to:**

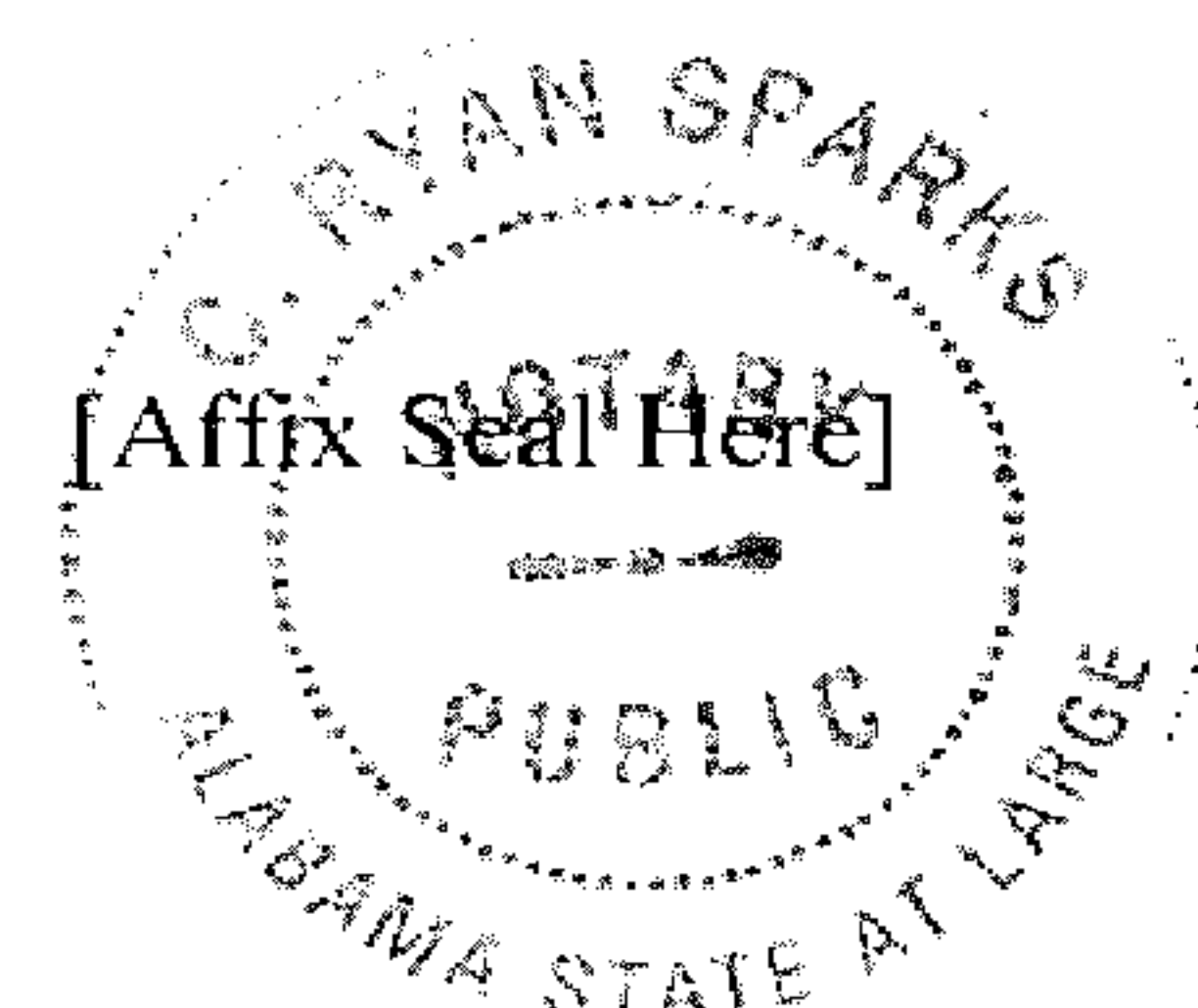



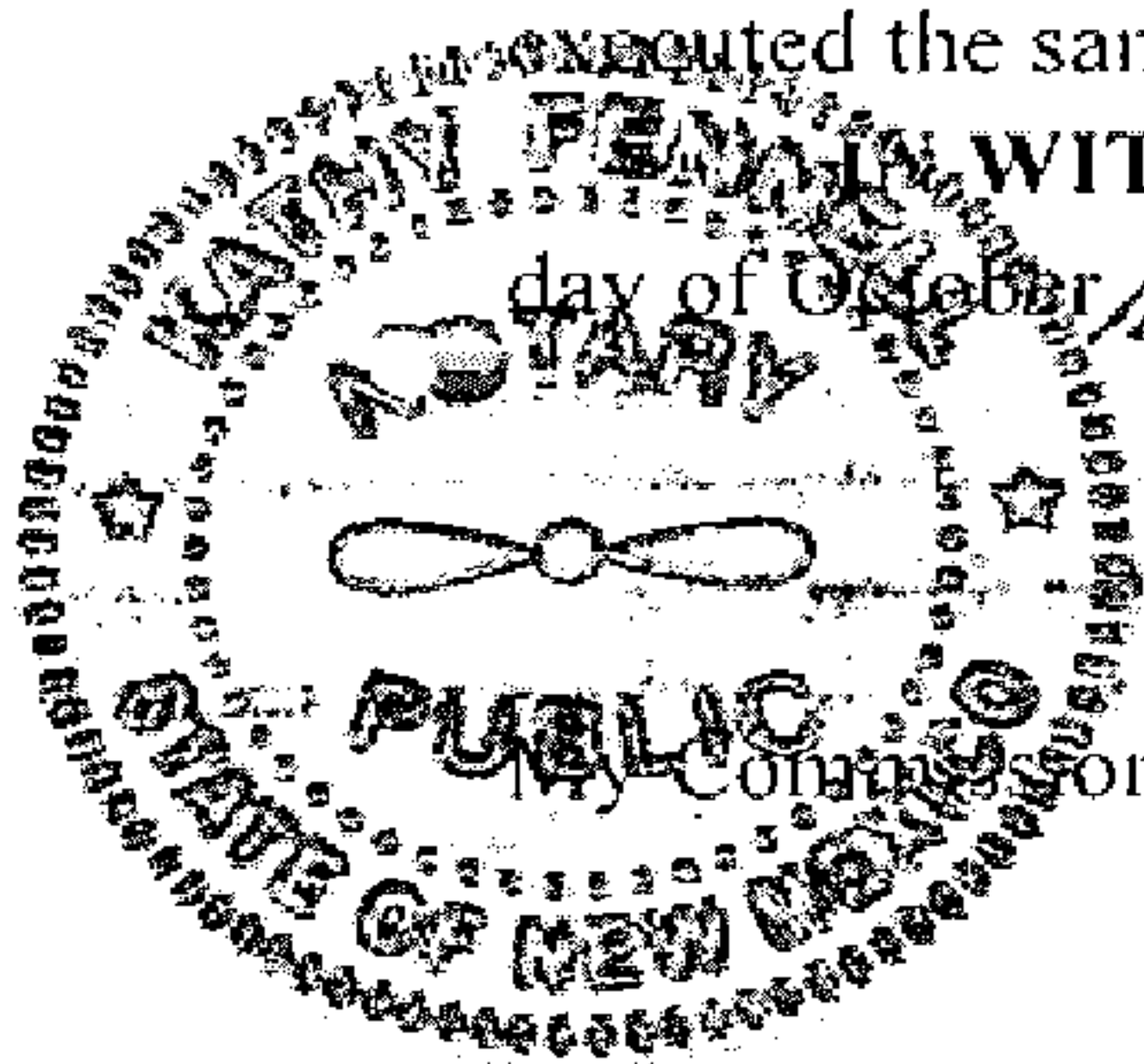
