Know All Men by These Presents: That in consideration of **Six Hundred Thirty Thousand and 00/100 Dollars (\$630,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **PATRICK W. 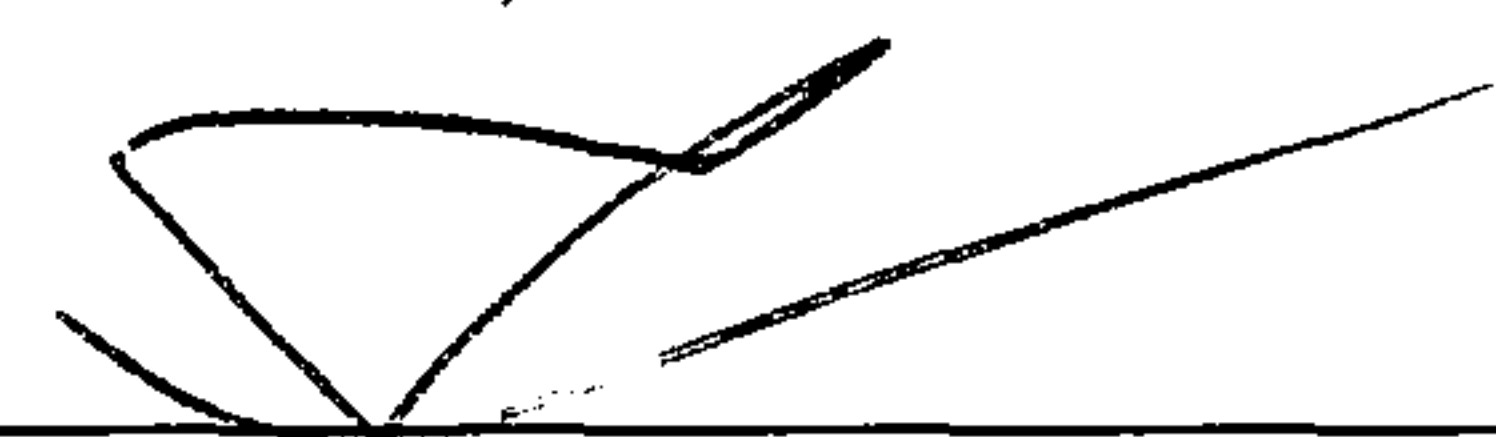

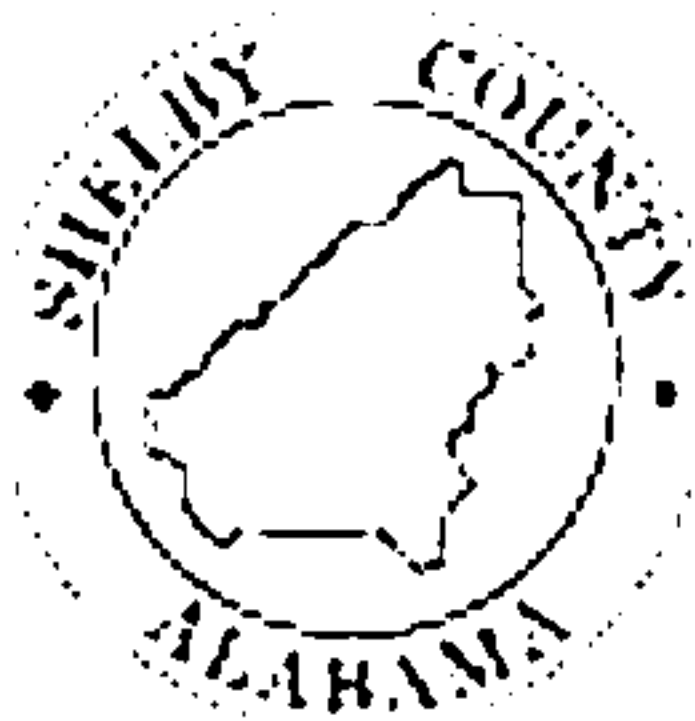
