**GENERAL WARRANTY DEED**

KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Eighty-Six Thousand Dollars and NO/100 (\$86,000.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Richard Lee Prewett and Yaqueline Olivera, husband and wife**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **Victor O. Mosqueda and Norma Loyola Reyes** (herein referred to as Grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in SHELBY County, Alabama to wit:

**A parcel of land in the NE ¼ of the NW ¼ of Section 17, Township 21 South, Range 3 West, Shelby County, Alabama, described as follows:**

**Commence at the SE corner of the NE ¼ of the NW ¼ of Section 17, Township 21 South, Range 3 West, Shelby County, Alabama and run thence Westerly along the South line of said ¼ - ¼ a distance of 339.17 feet to a point; thence turn 88 degrees, 01 minutes, 40 seconds to the right and run Northerly 586.46 feet to the point of beginning of the property being described; thence turn 109 degrees, 58 minutes, 28 seconds to the left and run West-Southwesterly 57.32 feet to a point; thence turn 92 degrees, 39 minutes, 43 seconds to the right and run Northerly 192.13 feet to a point on the Southerly margin of Shelby County Highway No. 260; thence turn 88 degrees, 00 Minutes, 49 seconds to the right and run Easterly along said margin of said Highway 154.61 feet to a point; thence turn 98 degrees, 58 minutes, 04 seconds to the right and run Southerly 192.64 feet to a point; thence turn 80 degrees, 16 minutes, 24 seconds to the right and run West-Southwesterly 73.65 feet to the point of beginning; being situated in Shelby County, Alabama.**

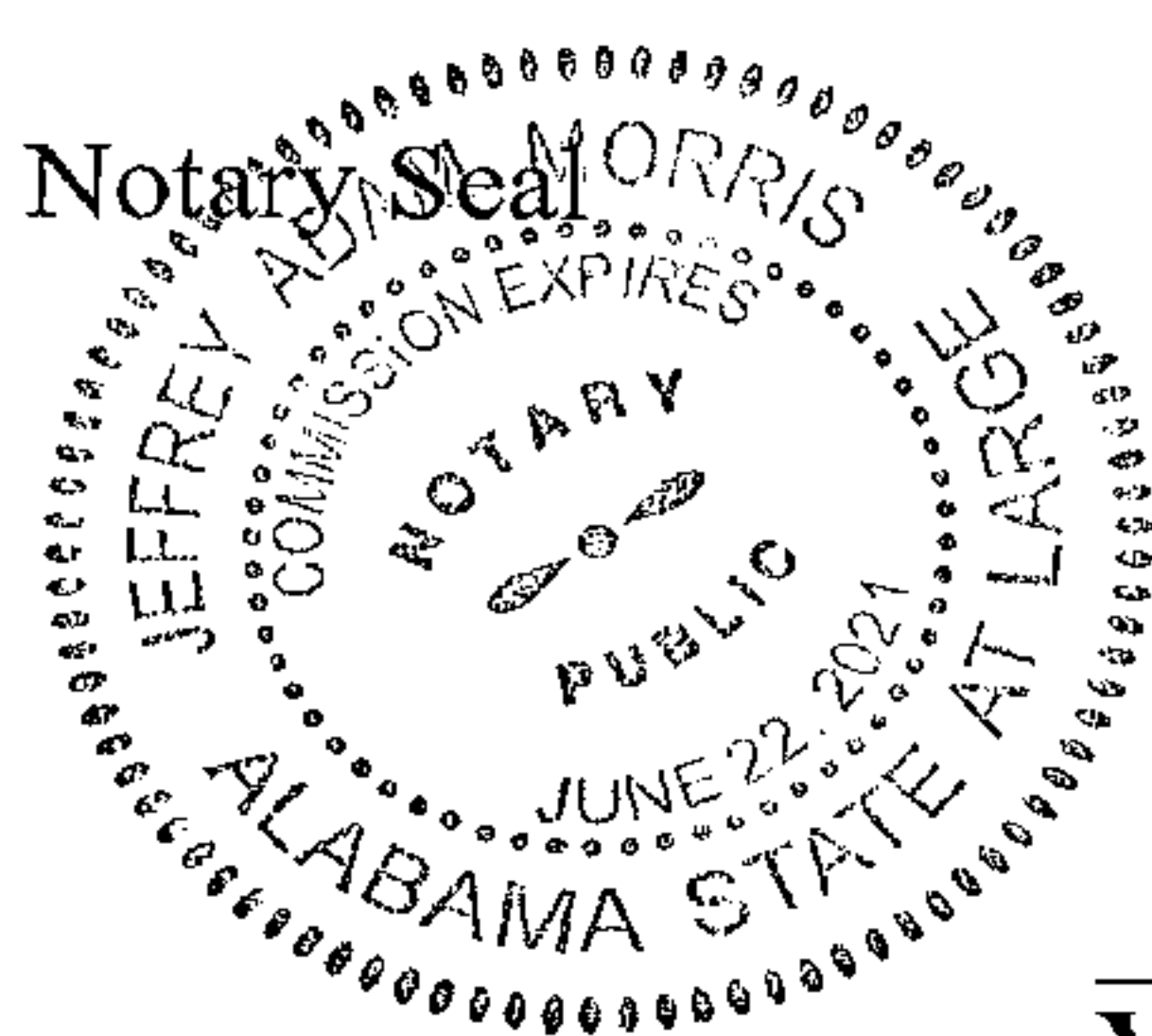

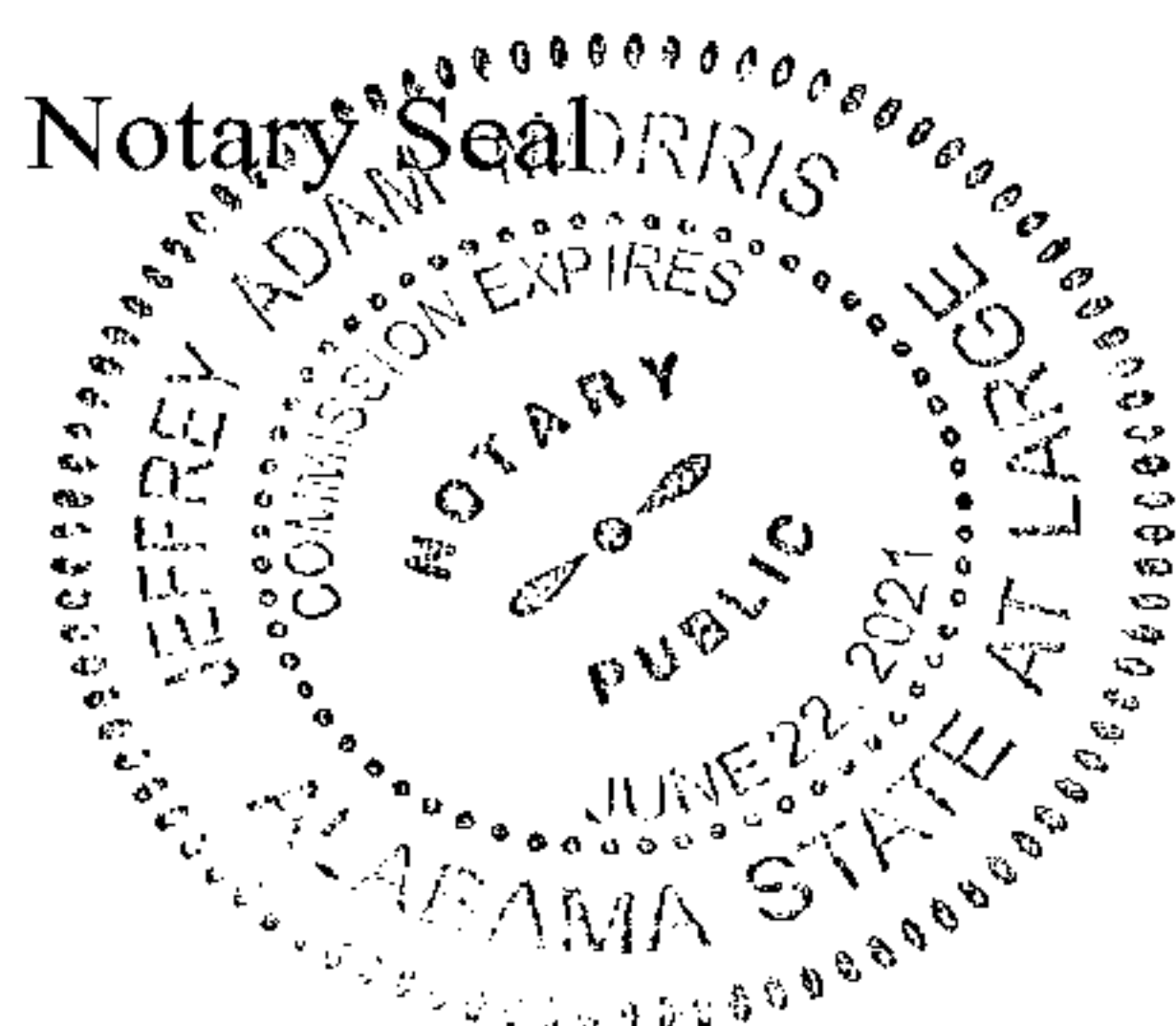
