WARRANTY DEED
Joint Tenancy With Right of Survivorship

KNOW ALL MEN BY THESE PRESENTS, that in consideration of **One Hundred Forty Five Thousand Dollars and No Cents (\$145,000.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **James Ryan Holtzapfel and Crystal Dawn Holtzapfel, husband and wife** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto **Roy Brent Harlan and Lori Hill Harlan** (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 13, according to the Survey of Park Place Second Addition, as recorded in Map Book 17 page 16 in the Probate Office of Shelby County, Alabama.

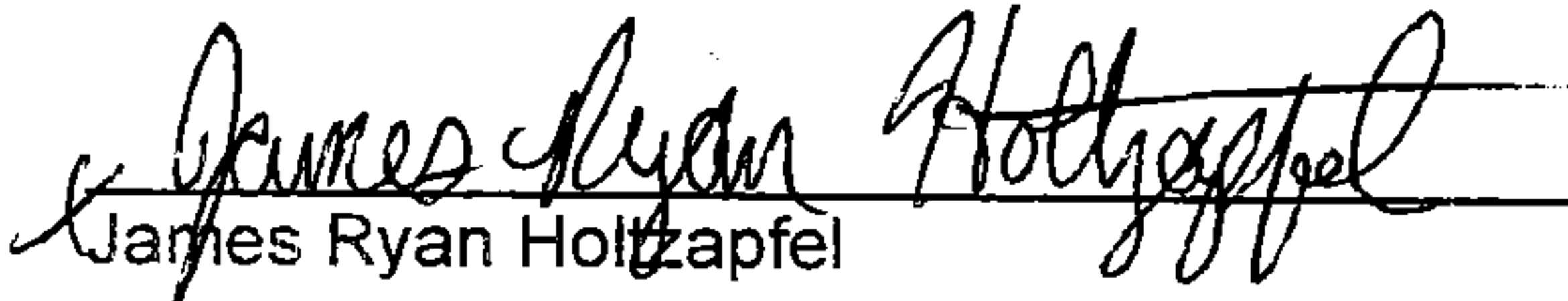
Note: \$116,000.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

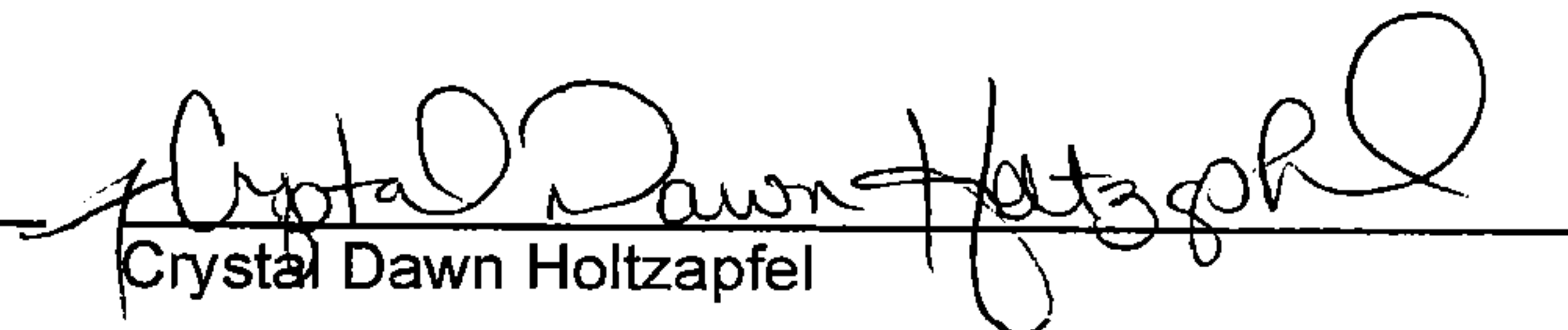
Grantor Crystal Dawn Holtzapfel is also known as Crystal D. Stifflemire
