

CERTIFICATE OF FORMATION
OF
JOHN THE REAL MENU MAN LLC

THE UNDERSIGNED, for the purpose of forming a limited liability company pursuant to the provisions of the Alabama Limited Liability Company Law, as the same now exists or as may hereafter be amended (the “Law”), does hereby adopt the following Certificate of Formation:

ARTICLE I.

The name of the Company is “John the Real Menu Man, LLC” (the “Company”).

ARTICLE II.

The purposes for which the Company is formed are:

- (a) Marketing and sales support services.
- (b) To hold real estate for use in trade or business and/or for investment.
- (c) To transact any lawful business for which limited liability companies may be organized under the Law.

ARTICLE III.

The existence of the Company shall commence on January 1, 2020, or the date of the filing of this Certificate of Formation in the Office of the Judge of Probate of Shelby County, Alabama, whichever shall be later and shall be terminated upon the earlier to occur of (i) the written consent of all the members to terminate the Company; (ii) as provided in the Operating Agreement; or (iii) as may be required under the Law.

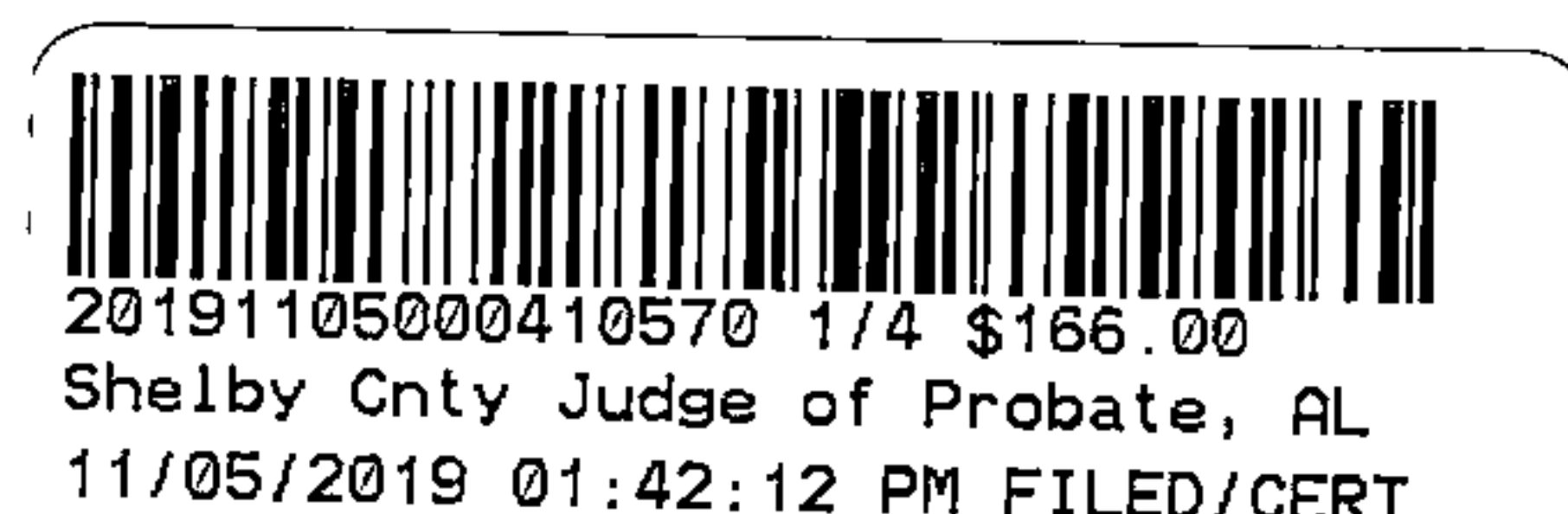
ARTICLE IV.

ARTICLE VI.

The Company shall admit additional members only upon the terms and conditions set forth in the Operating Agreement.

ARTICLE VII.

The cessation of membership of one or more members will result in termination of the Company if there are no remaining members, unless the legal existence and business of the Company is continued and one or more new members is appointed in the manner provided in the Operating Agreement.

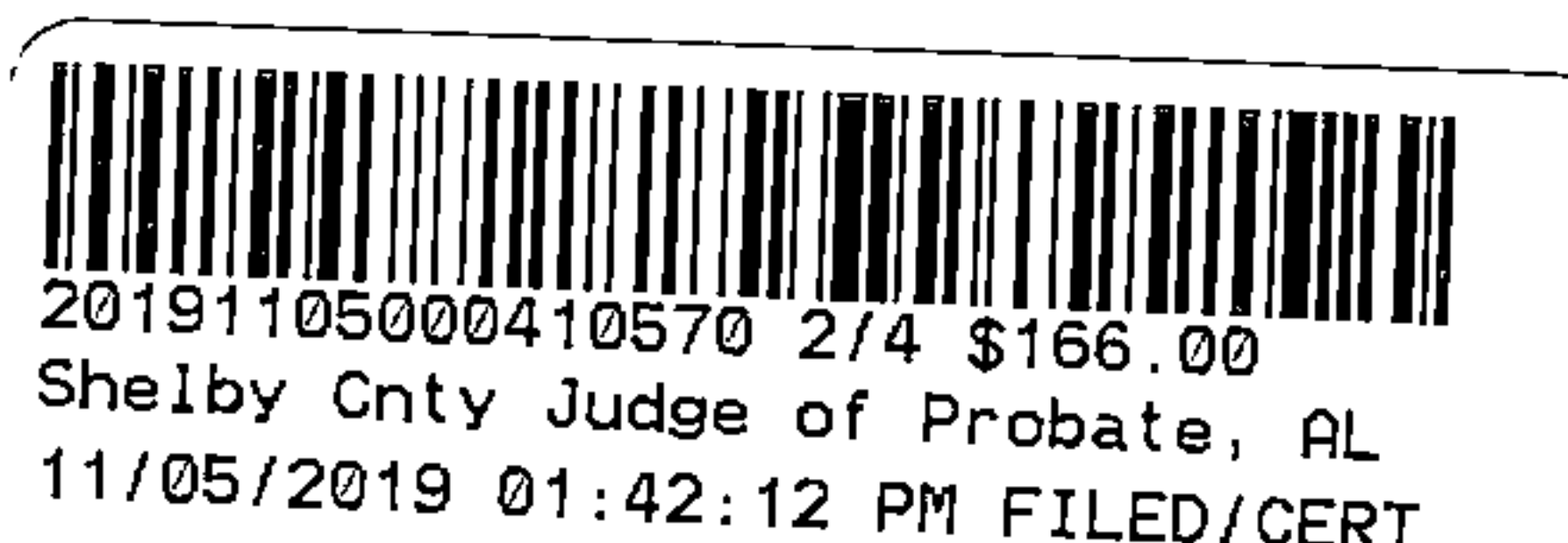

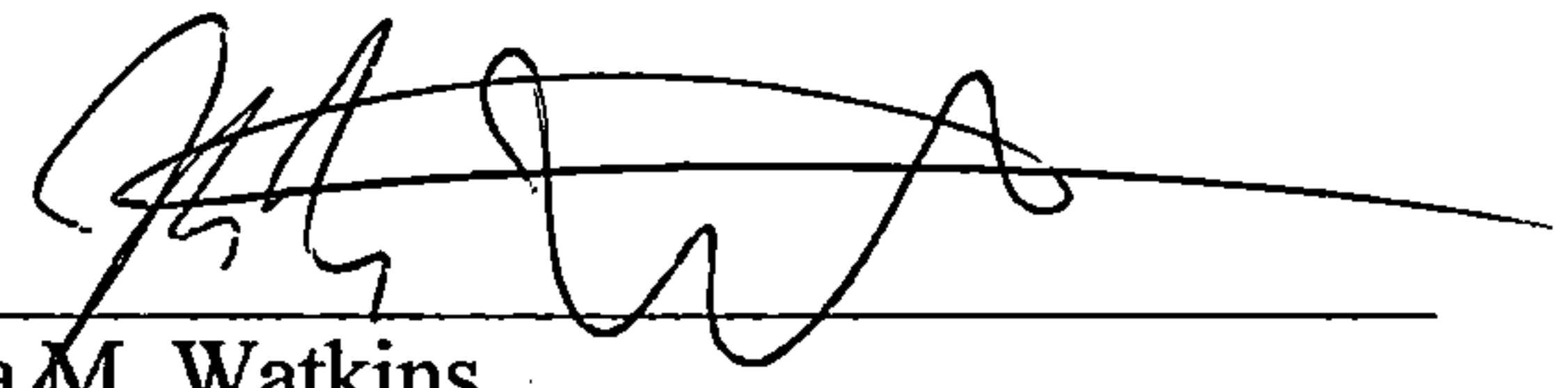
ARTICLE IX.

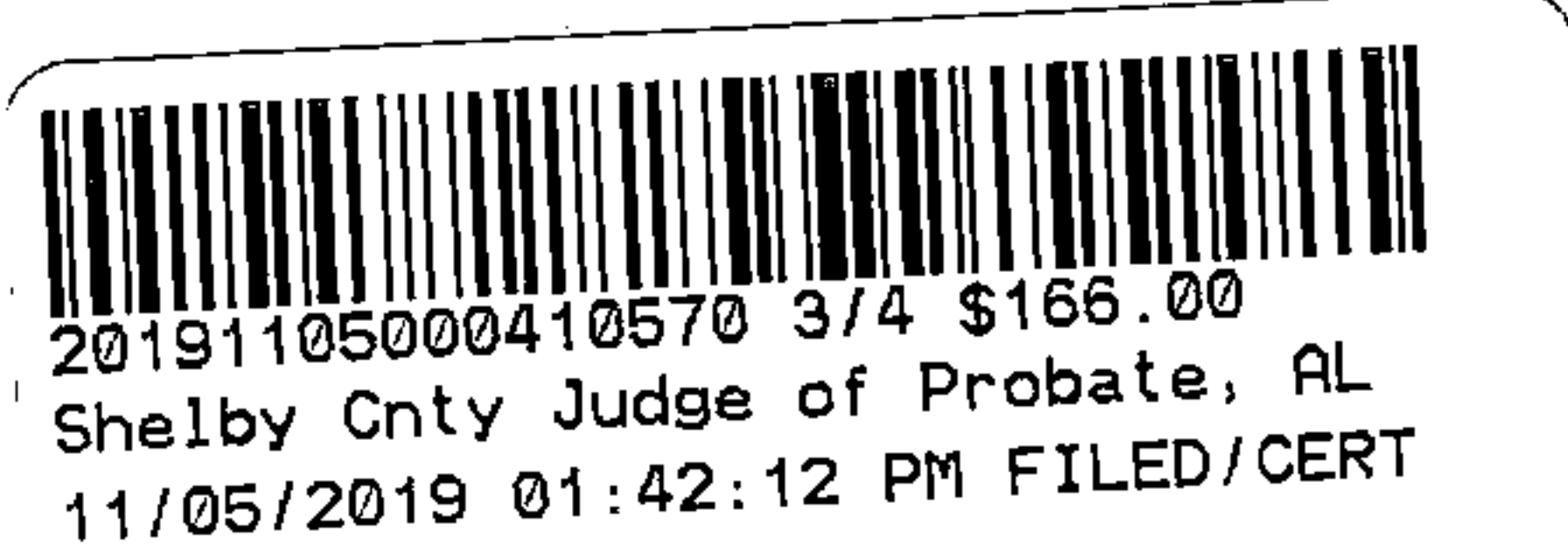
