**MORTGAGE FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 4th day of November, 2009, ROBERT STARR and BRIGETTE STARR, HUSBAND AND WIFE executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC AS NOMINEE FOR HOMETOWN MORTGAGE SERVICES INC., which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on November 6, 2009, at Instrument Number 20091106000416570, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **NATIONSTAR MORTGAGE LLC D/B/A MR. 
