KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two Hundred Eighty-Five Thousand And No/100 Dollars (\$285,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Linda F. 
