That for and in consideration of **TWO HUNDRED SIXTY ONE THOUSAND NINE HUNDRED AND NO/100 (\$261,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **THOMAS SLONNEGER and BRENDA B. SLONNEGER, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEE, **PEGGY R. HOWLAND, AS TRUSTEE OF THE PEGGY R. HOWLAND LIVING TRUST DATED SEPTEMBER 17, 2013**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:


