OF

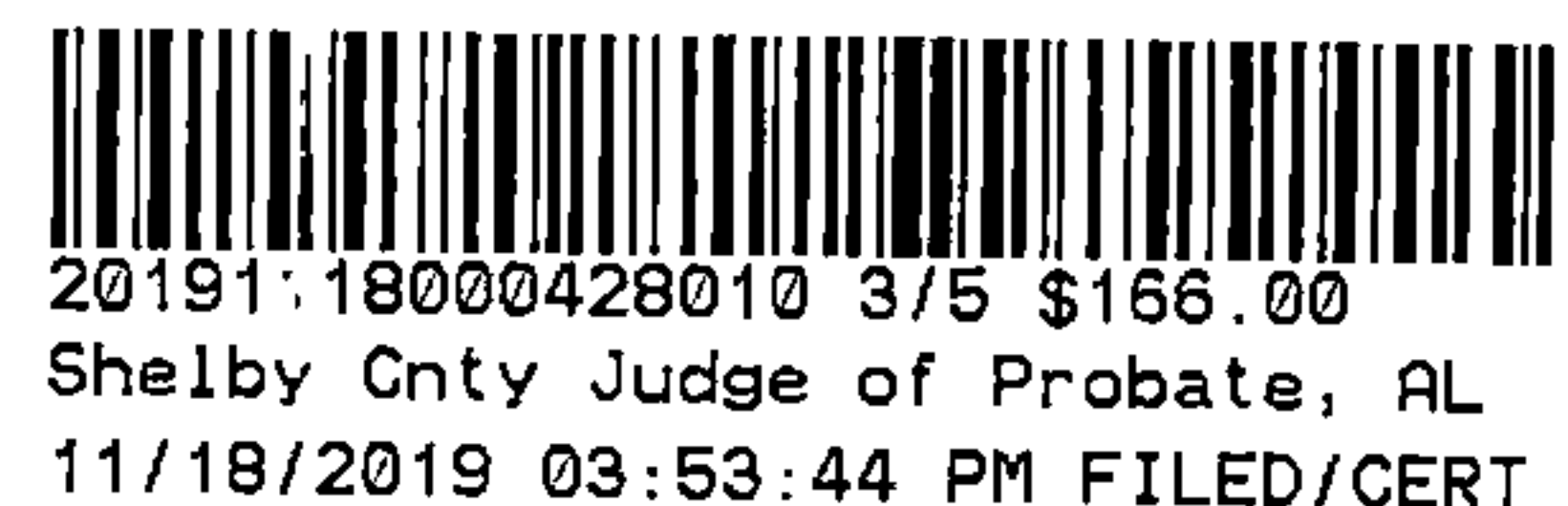

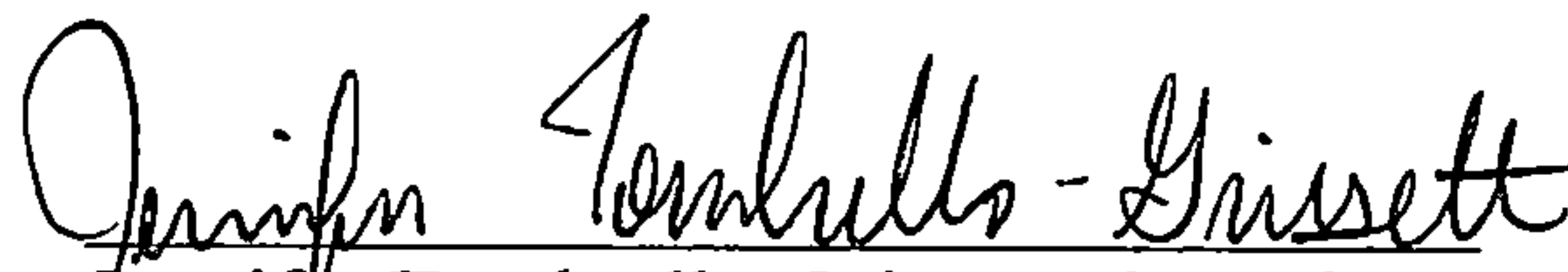
