KNOW ALL MEN BY THESE PRESENTS,

On this November 19, 2019, That for and in consideration of **EIGHTEEN THOUSAND AND N0/100 (\$18,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **JAG INVESTMENT STRATEGIES, LLC, by James F. Williams, as Member-Manager**, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEES, **BARRY NEAL KEY, JR. and TRACEY LYNN KEY**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:




