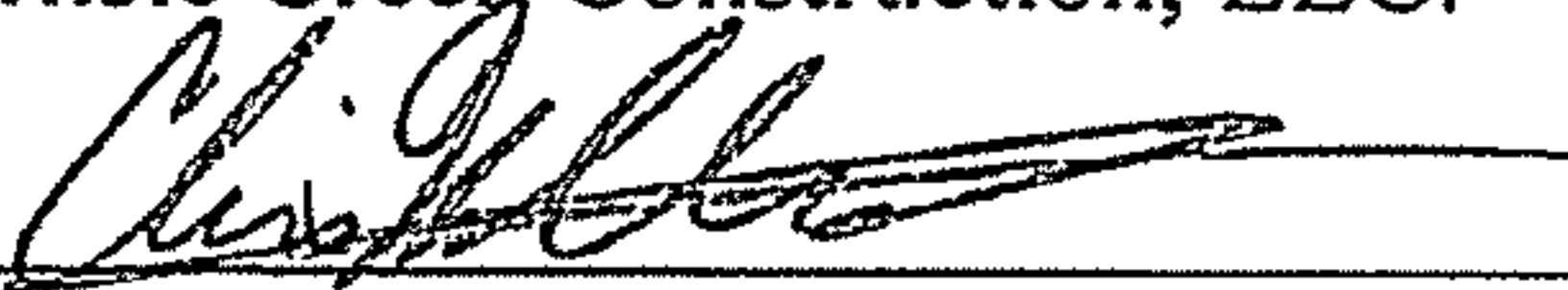
Mineral and mining rights excepted. Subject to current taxes, easements, conditions, covenants, and restrictions of record.

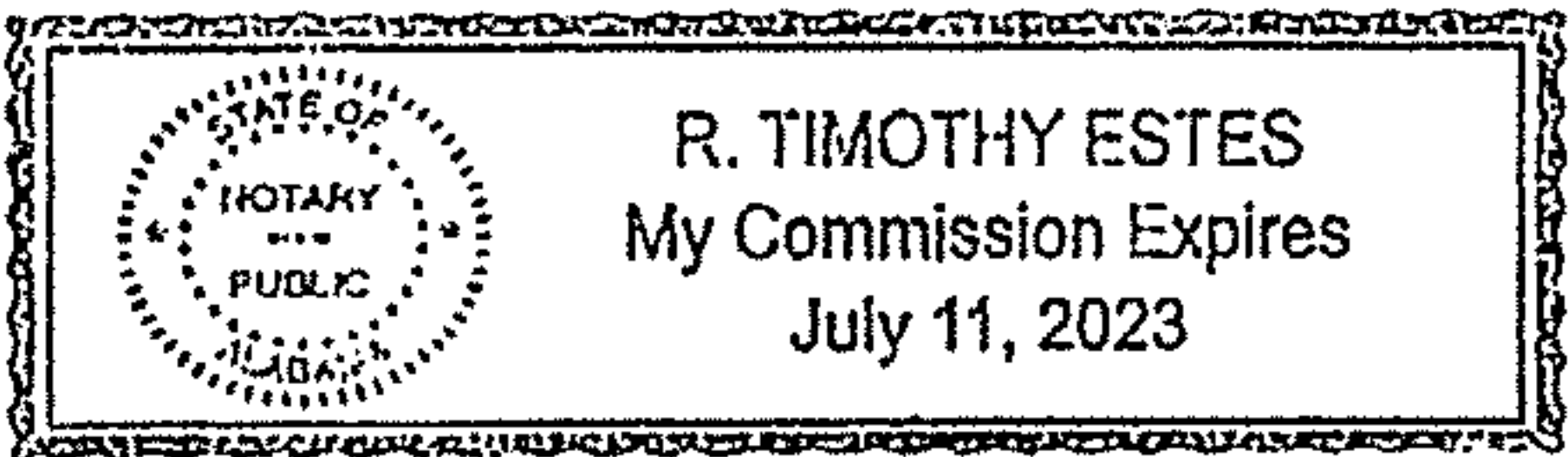

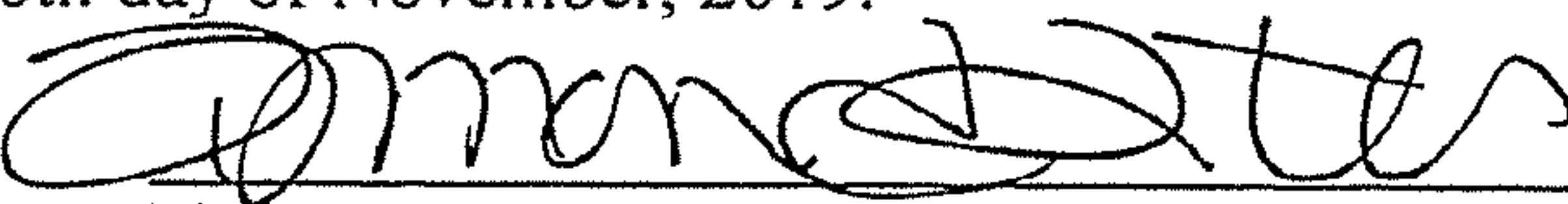

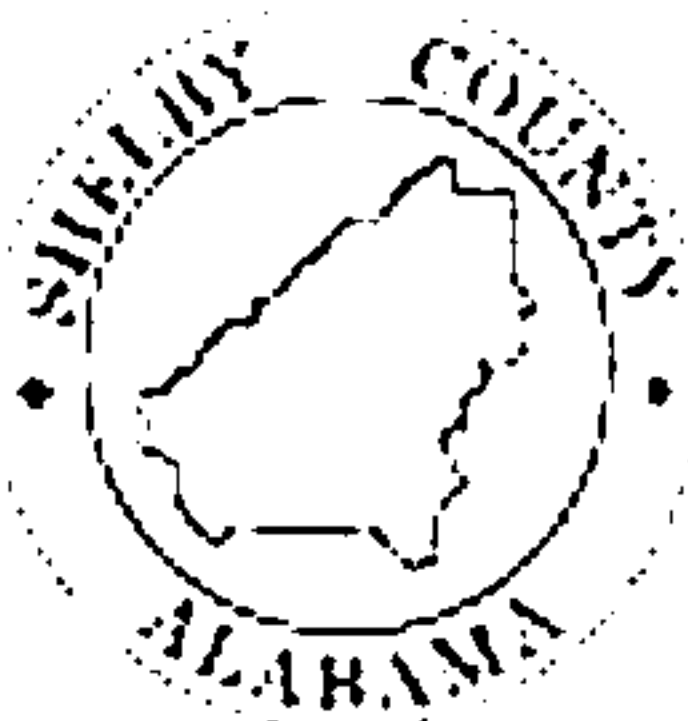
