

**ARTICLES OF ORGANIZATION

The undersigned, acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act (the "Act"), hereby adopt the following Articles of Organization for Pentoir Properties L.L.C. Limited Liability Company (hereinafter called the "Company").

1. The name of the Company Pentoir Properties L.L.C., a Limited Liability Company (LLC).
2. The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.
3. The Company is organized for the purpose of engaging in the business of Property Holdings and Management and/or any other legally authorized business in the State of Alabama as defined in the Code of Alabama and other business reasonably related to this type of business.
4. The mailing address of the initial registered office is 404 Business Center Drive Birmingham, Alabama 35244 and the name of the initial registered agent of the Company at such address is Jonathan E. Stephens.

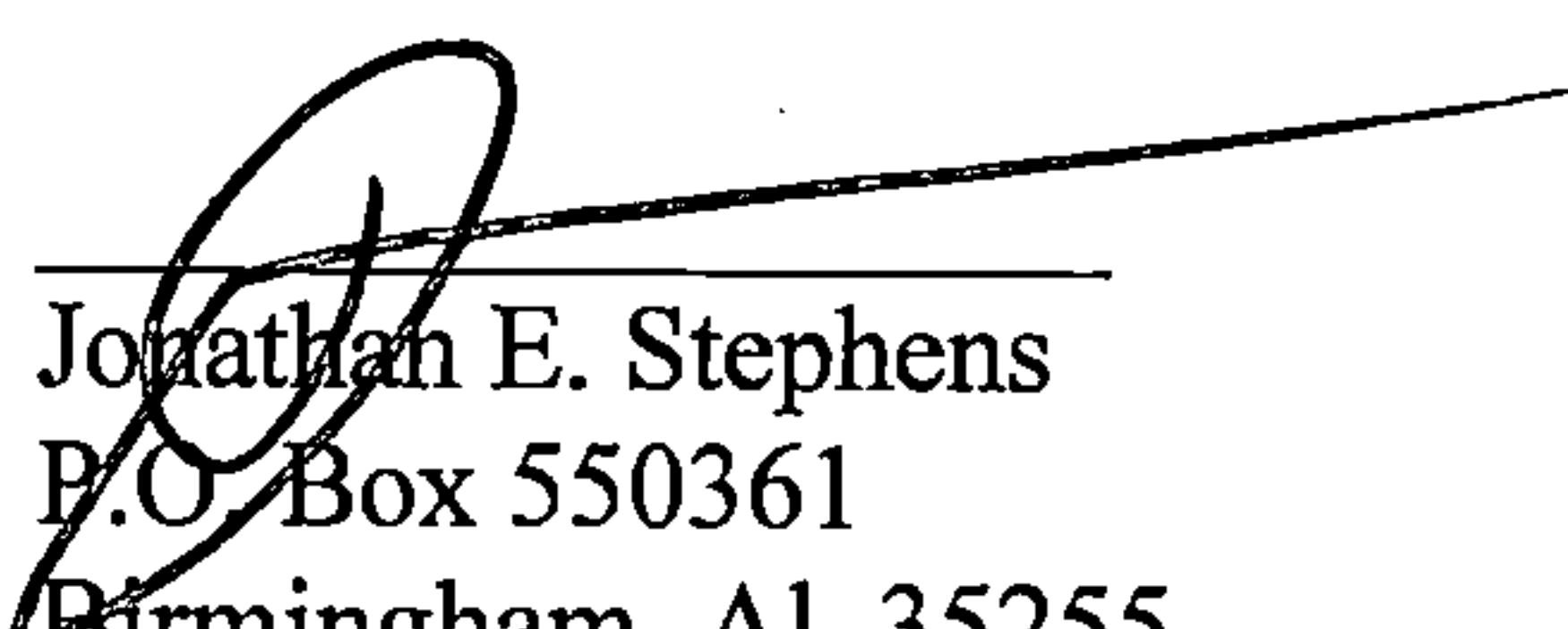

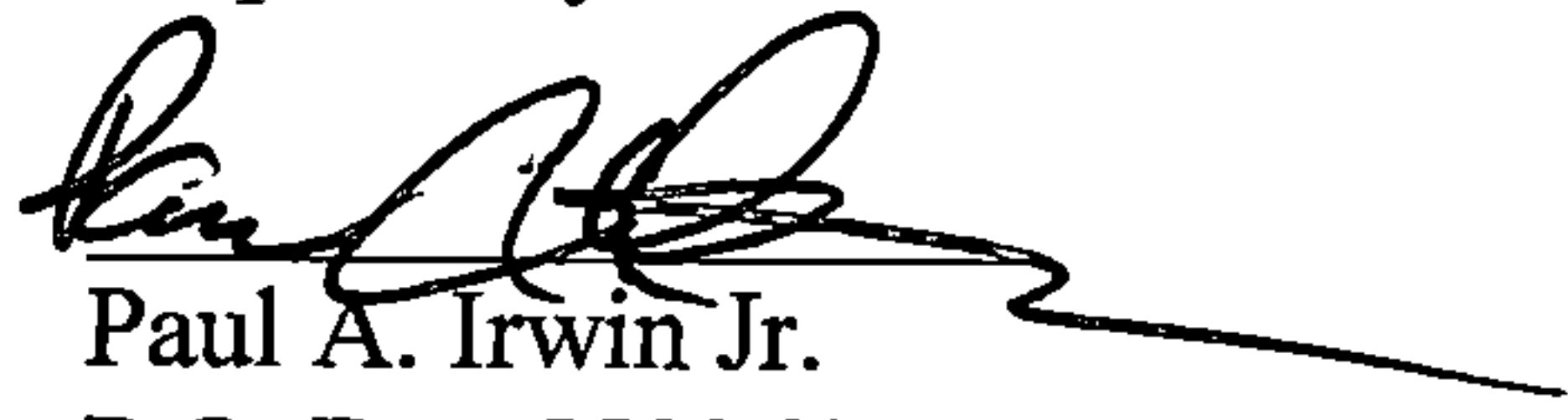
6. The initial member of the Company may admit additional members at such times and upon such terms and conditions as may be agreed by the Company and the additional members.
