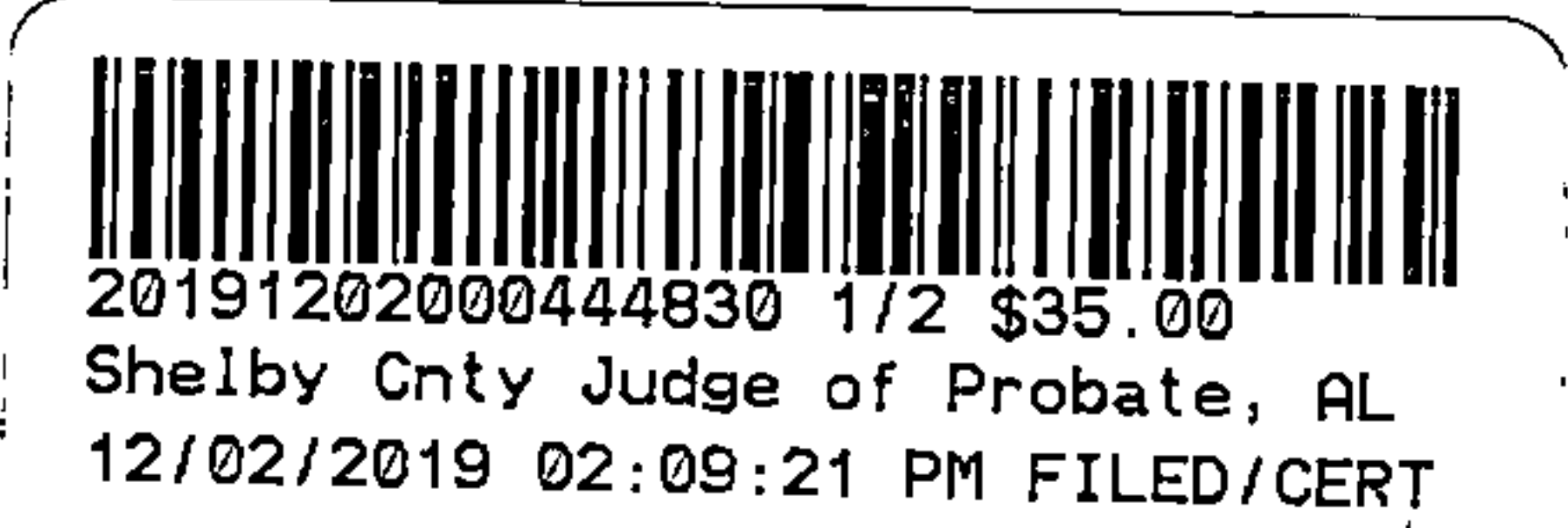

WARRANTY DEED

STATE OF ALABAMA )  
SHELBY COUNTY ) KNOW ALL MEN BY THESE PRESENTS:

That in consideration of TEN THOUSAND DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

CANDICE BURTON, AN UNMARRIED WOMAN

(herein referred to as Grantor, whether one or more), grants, bargains, sells, and conveys unto

CANDICE A. BURTON, TRUSTEE, OR HER SUCCESSORS IN TRUST, UNDER THE BURTON LIVING TRUST, DATED NOVEMBER 18, 2019, AND ANY AMENDMENTS THERETO.

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 9, according to the Survey of Phillips Addition to New Hope Mountain as recorded in Map Book 10, Page 20, in the Office of the Judge of Probate of Shelby County, Alabama.

Candice A. Burton is the surviving Grantee in that certain warranty deed with right of survivorship recorded at instrument number 20160912000330640, dated September 9, 2016. The other Grantee Bradley R. Burton, died on or about December 12, 2017. A copy of his death certificate is attached.

Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

TO HAVE AND TO HOLD to the said grantee, his, her or their successors and assigns forever.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEE, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEE, his, her or their successors and assigns forever, against the lawful claims of all persons.

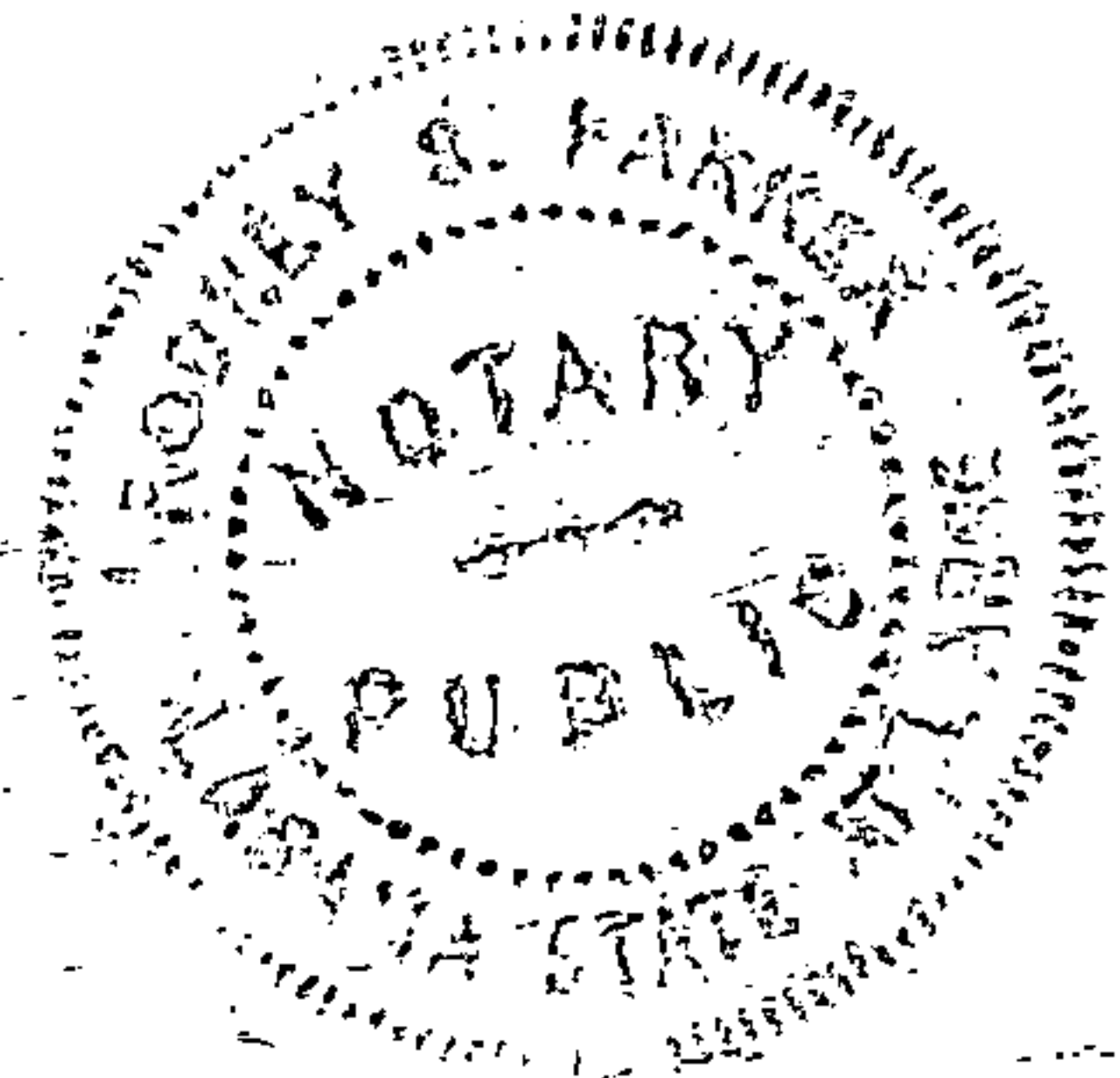
