#### LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that IHS 2 LLC (the "Company") hereby names, expressly constitutes and appoints, in furtherance of the Master Services Agreement dated June 30th, 2017, as well as that certain Statement of Work — Cash For Deed Asset Management Services dated June 30th 2017 (collectively, the "Services Agreement"), entered into between the Company, an affiliate of IHS 1 LLC and Innomax Home Solutions LLC, and Altisource Solutions S. à r.l. (together with its parent companies, subsidiaries and affiliates, "Altisource"), (i) any member of the Board of Directors of Altisource Solutions, Inc., a wholly owned subsidiary of Altisource S.à r.l. I (a successor in interest of Altisource Solutions S.à r.l.), and (ii) Benjamin B. Smith (so long as Mr. Smith is employed by Altisource Solutions, Inc.), individually, as its true and lawful attorneys-in-fact to act in the name, place and stead of the Company for the limited purposes set forth below and to sign, seal and deliver all documents reasonable and necessary related to certain real property described on attached Exhibit A (collectively, the "Properties").

This Limited Power of Attorney supersedes any power of attorney previously executed by the undersigned regarding the purposes outlined in the first paragraph hereof ("Prior Powers of Attorney"), and the authority of the attorneys-in-fact named in any Prior Powers of Attorney is hereby revoked.

The said attorneys-in-fact, and each of them individually, are hereby authorized, and empowered, on the Company's behalf, as follows:

- (1) To execute acknowledge seal and deliver the following documents, appropriately completed, with all ordinary or necessary endorsements, acknowledgments, affidavits, and supporting documents as may be necessary or appropriate for the sale, transfer, grant conveyance, bargaining, recording or filing of the Properties, including listing agreements, purchase and sales agreements, any and all transactional documents necessary or appropriate to finalize the sale of all or any of the Properties, including any deeds and supporting documents; and
- (2) To assign and appoint employees of Altisource to act on the Company's behalf to carry out any rights and powers that are within the scope of Section 1 above and any other rights and powers necessary to provide the services contemplated within the Services Agreement, such appointment to be (i) revocable upon notice, with or without cause, and for any reason and (ii) immediately terminated, without any notice or further action, upon the termination of the individual's employment with Altisource.

NOTWITHSTANDING THE ABOVE APPOINTMENT this power will cease and be null and void, and any documents or acts signed or undertaken with respect to such transactions herein contemplated shall be void and of no effect, unless executed within 365 days of the execution of this document.


