

DOMESTIC LIMITED LIABILITY COMPANY CERTIFICATE OF AMENDMENT

PURPOSE: In order to amend a Limited Liability Company's (LLC) Certificate of Formation under Section 10A-5A-2.02 of the Code of Alabama 1975 this Amendment and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the LLC was initially formed.

INSTRUCTIONS: Mail one (1) signed original and two (2) copies of this completed form and the appropriate filing fee to the Office of the Judge of Probate in the county where the LLC's Certificate of Formation was recorded. Contact the Judge of Probate's Office to determine the county filing fees. Make a separate check or money order payable to the Secretary of State for the state filing fee of

\$50.00 for standard processing (based on date of receipt and volume) or \$150.00 for expedited processing (within 24 hours after receipt from the County Probate Office) and the Judge of Probate's Office will transmit the fee along with a certified copy of the Amendment to the Office of the Secretary of State within 10 days after the filing is recorded. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment (see attached). Your filing will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored (\$30.00 fee).




AMENDED RESOLUTION OF THE MEMBERS OF FARMOR, LLC

The undersigned, constituting all of the members of FarMor, LLC, an Alabama limited liability company (the "Company"), hereby consent to, approve, and adopt the following resolution in lieu of holding a meeting:

1. The Members and Ownership Percentage of FarMor, LLC are amended as follows:

Connor Farmer -	Managing Member -	30%
Steve Mordecai -	Managing Member -	30%
Cooper Johnson -	Investment Member -	20%
Macy Smith -	Investment Member -	20%

- 2. The Company is to be Managed by Connor Farmer and Steve Mordecai as the Managing Members. That said Managing Members shall be due from the company a distribution equal to the net profit of the sale of said real property hereinafter defined. Said Distribution shall be deemed a management fee payable 50% to each Managing Member.
- 3. The Company desires to purchase and sell real property located at 419 Main Street, Trussville, Jefferson County, Alabama (the "Property"). A portion of the money used to purchase said property shall be obtained by the Company entering into a note and purchase money mortgage with FBA Doc. (the "Lender"). Said action would require the Company to execute notes, mortgages, financing instruments and other loan documents with Lender to secure the repayment of said incurred debt (cumulatively the "1st Mortgage"). Only the managing members, as described above, may be required to personally guarantee the loan proceeds. That a portion of said Property shall be donated to the City of Trussville in return for a "Gift Letter".
- 4. That additional purchase money funds in the amount of \$300,000.00 shall be obtained from Cooper Johnson, Investment Member. Cooper Johnson shall hold a 2nd Mortgage, subordinate to that of Lender. Said 2nd Mortgage shall be satisfied by the Company prior to the distribution of any management fees or profits to Members.
- 5. That additional purchase money funds in the amount of \$300,000.00 shall be obtained from Macy Smith, Investment Member. Macy Smith shall hold a 3rd Mortgage, subordinate to that of Lender and that of Cooper Johnson. Said Mortgage shall be satisfied by the Company prior to the distribution of any management fees or profits to Members.
- 6. That Cooper Johnson (the "Investment Member") shall be paid by the Company an Origination Fee equal to 1% of his principal loan amount to the Company. He shall also receive a percentage, equal to his ownership interest in the Company, of any tax deduction incurred as a part of this transaction or as a result of said Gift Letter.



- 7. That Macy Smith (the "Investment Member") shall be paid by the Company an Origination Fee equal to 1% of his principal loan amount to the Company. He shall also receive a percentage, equal to his ownership interest in the Company, of any tax deduction incurred as a part of this transaction or as a result of said Gift Letter.
- 8. That if the Managing Members enter into a contract to sell the Property as a whole and close on said contract prior to January 31st, 2020, then each Investment Member shall receive a fee equal to 10% of his principal loan investment in lieu of the tax deduction as described in Paragraph #6 and #7.

9.	That this Amended Resolution shall replace in its entirety the previously executed
	Resolution dated the 28 day of 10 follow, 2019.
