FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of May, 2009, Williamson Ringgold Hynson and Jennifer L. Hynson, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Hometown Mortgage Services, Inc. an Alabama Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090526000197220; corrected by Scrivener's Affidavit in Instrument Number 20181108000395490 , said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC, by instrument recorded in Instrument No. 20131002000394700, in the aforesaid Probate Office ("Transferee"); and

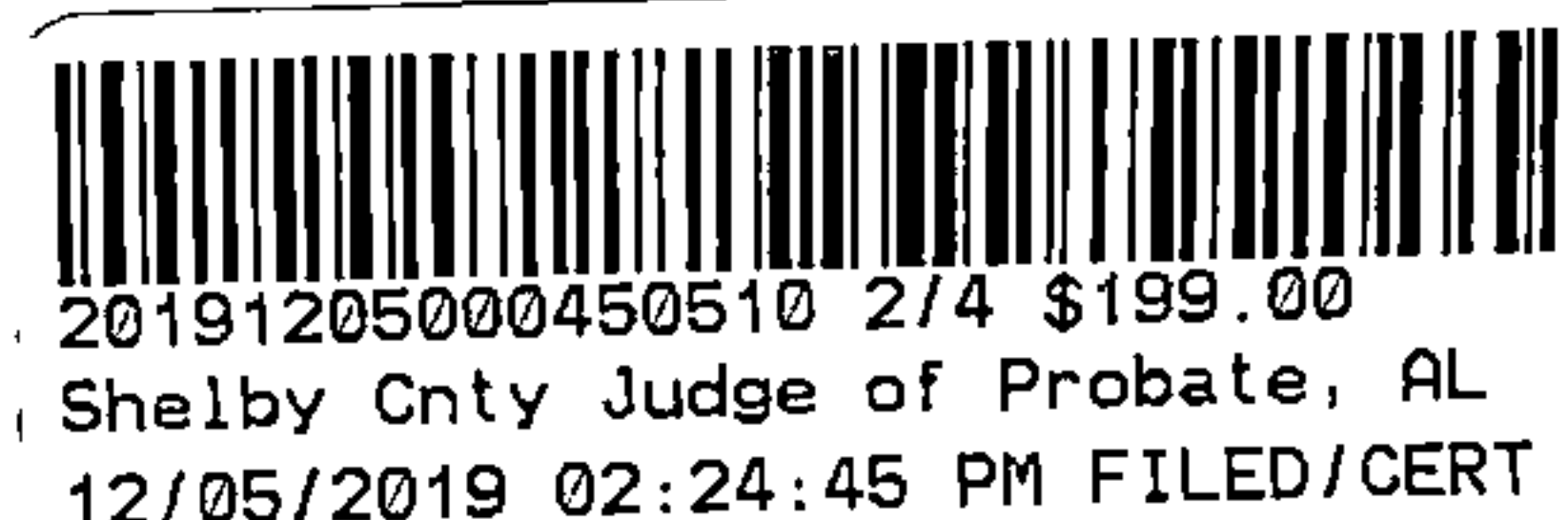

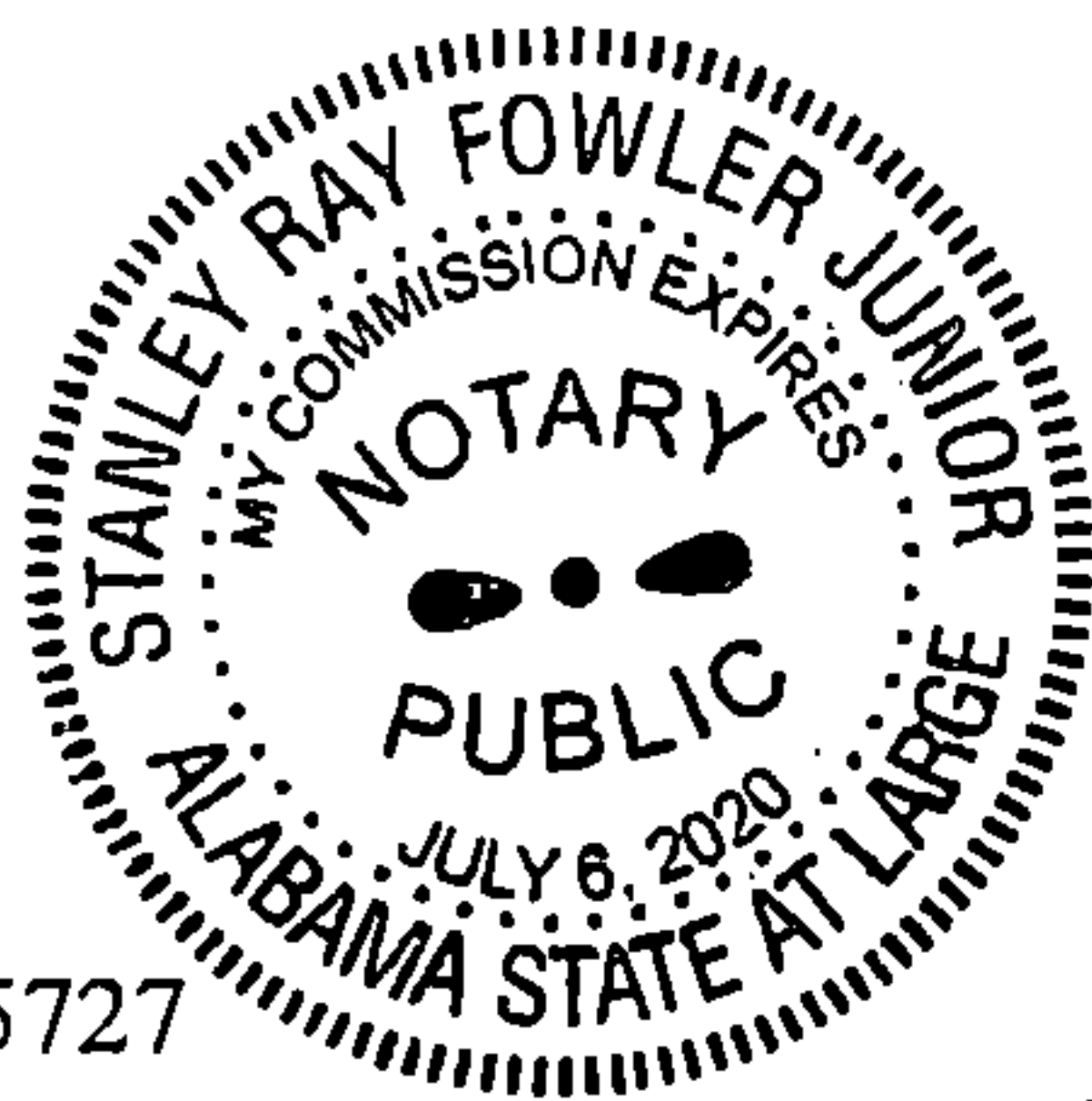
