

VERIFIED STATEMENT OF LIEN

Come now, Parker & Sons Heating & Cooling, Inc., an Alabama corporation, and hereby files this statement in writing, verified by oath of Vincent C. Golden, Vice President, who has personal knowledge of the facts herein set forth:

That Parker & Sons Heating & Cooling, Inc., claims a lien upon the hereafter described real estate situated in Shelby County, Alabama. Said real estate known as 4041 Langston Ford Drive, Lake Wilborn Phase 3, Hoover, Alabama, and situated in Shelby County, Alabama, and described to-wit:
