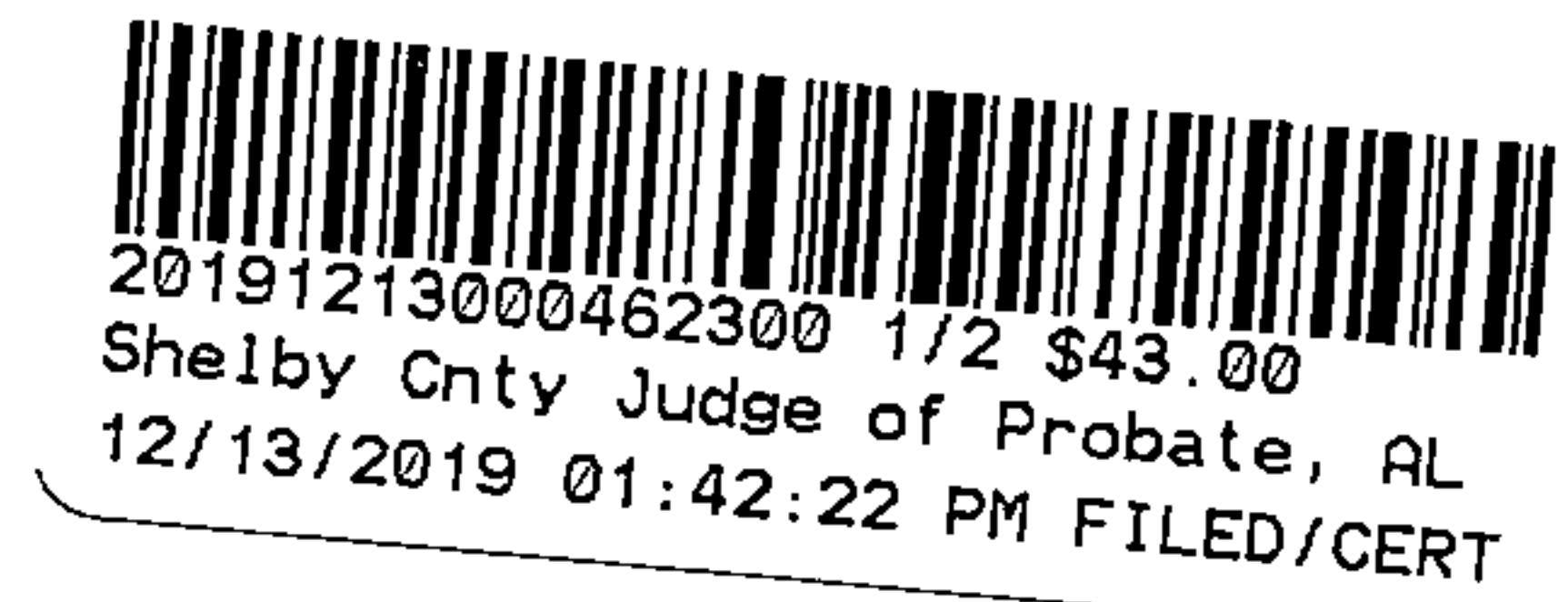

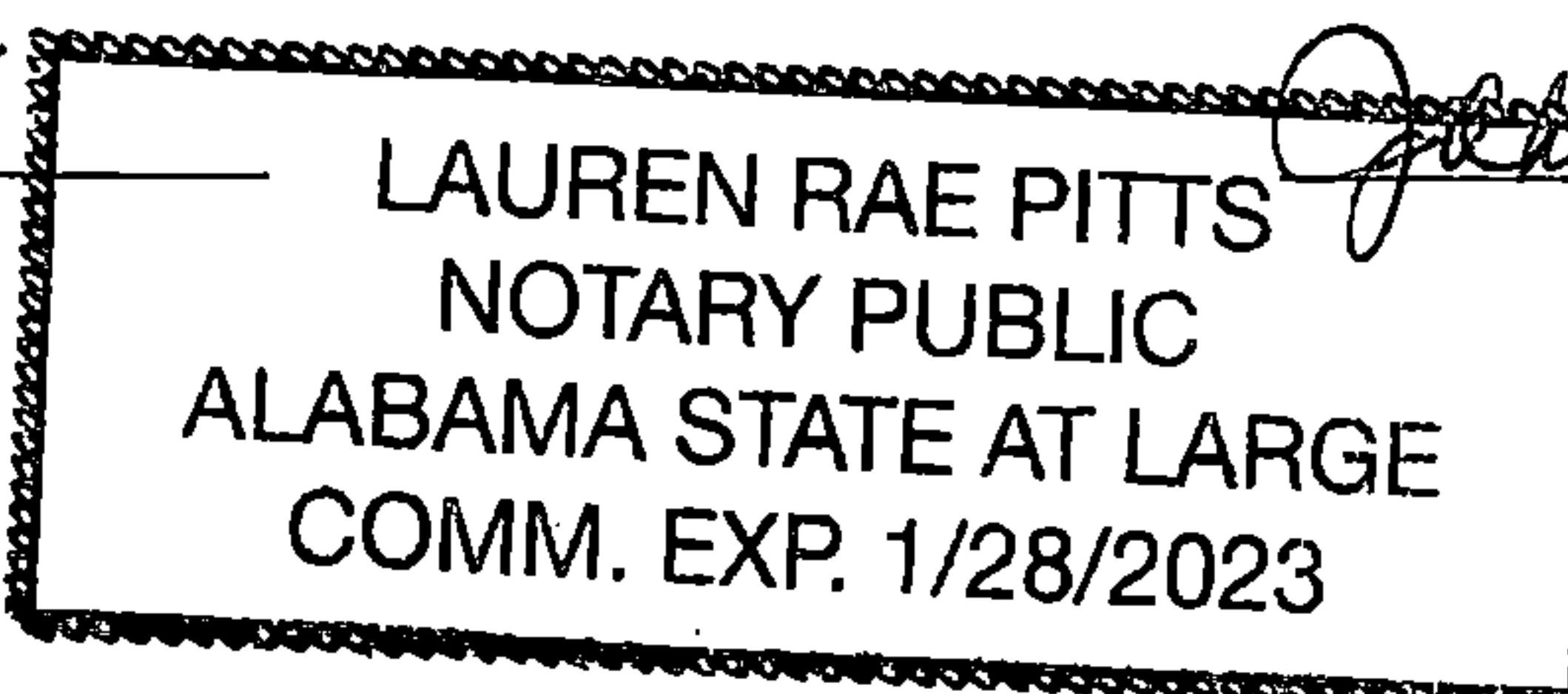
OATH OF OFFICE

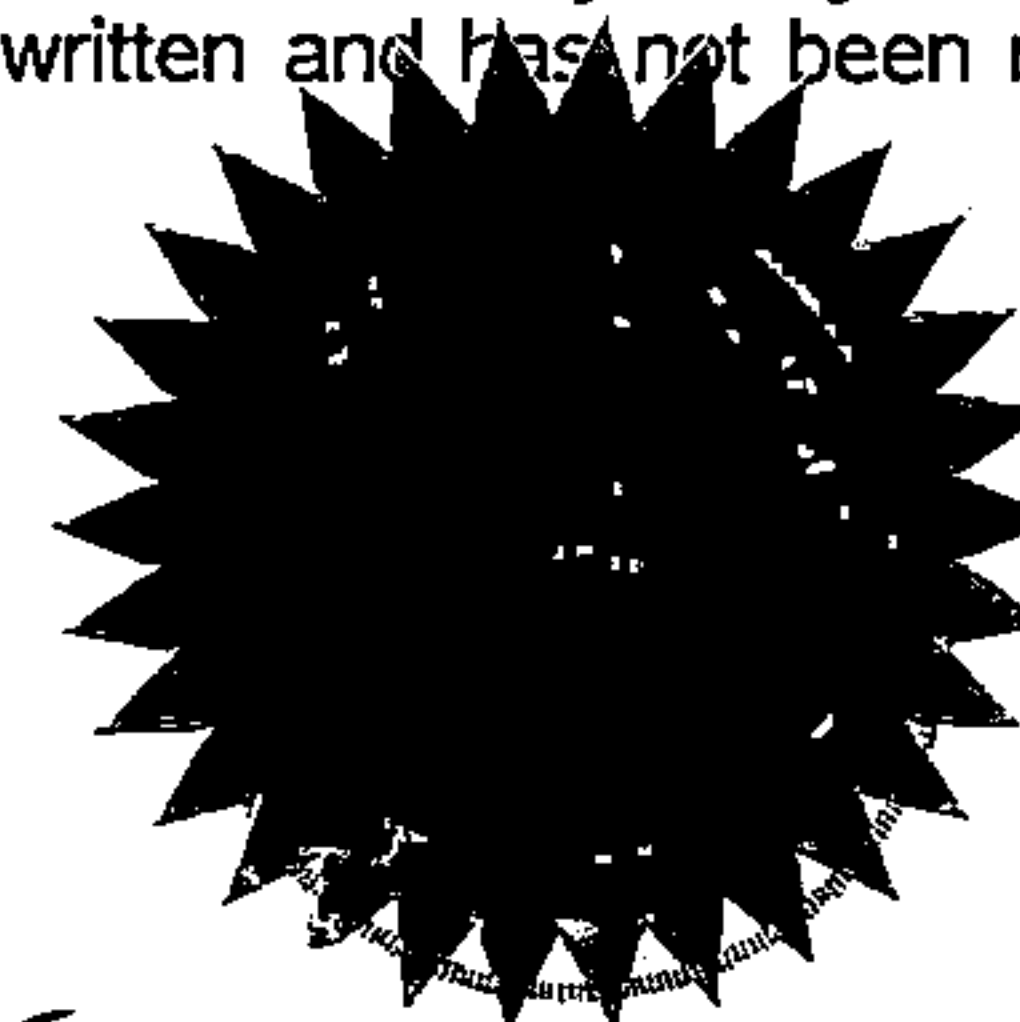
